# 2. ADDITIONS, DELETIONS, OR CHANGES TO THE AGENDA

## A. PUBLIC HEARING: Town Plan Update

Michael Allen introduced the Town Plan Draft 2.0:

- Timeline of the Town Plan revision
- "Goals" of the Town Plan, timeframes and parties responsible for the individual goals were explained
- Updated change in "look" of the document
- Introduction of the new Zoning Map

#### Question & Answer Session:

- Q: What are the next steps to the changing in Zoning regulations introduced in the New Town Plan?
- A: Once the Town Plan has been approved, the Planning Commission will continue to work with ReGrowth to update the Development Regulations. These regulations will go through a similar process of approval to the Town Plan.
- Q: How is the Town Plan revision being financed?
- A: The Selectboard allocated ARPA funds for both the Town Plan and Development Regulations
- Q: Is the Georgia Public Library Board of Trustee's goals for bringing the library into ADA compliance represented in the new Town Plan?
- A: Yes, with a goal for reaching ADA compliance within two years.
- T. Cleveland wanted to make sure this was included, as well as to thank the Planning Commission for the additional information provided on the Georgia Public Library.
- Q: Has the Town of Georgia has applied for Village Designation in the past?
- A: S. Brown explained the Planning Commission has made efforts toward Village Designation with the State of Vermont, however, because we did not have the necessary language in our Town Plan, Georgia was not considered a candidate. The Planning Commission plans to pursue Village Designation once the new Town Plan is in place.
- Discussion was had in regard to rezoning and non-conforming lots in the newly expanded business district, as well as changing the residential density zone along Route 7.
- A statement was made to ensure the Town Plan included "known wildlife" on the relevant maps, given that some areas of town have not been widely explored to determine wildlife corridors.
- A request was made for the Town Plan to include Transportation Trails, connecting some housing and neighborhoods and allowing for walkable trails.
- K. Waite Thanked the Planning Commission, Zoning Staff and ReGrowth Planning for their time and energies in drafting the new Town Plan.

# B. Planning Commission Hearing Summary and Discussion

- Planning Commission members recapped the Public Hearing and discussed the potential changes to the Town Plan Draft.
- The Future Land Use Vision map was examined, and changes were made to the Business District and higher density residential areas along Route 7.

- A map indicating properties in "Current Use" and "Land Trust" was asked to be included in the Town Plan in relation to the Wildlife Areas map.
- D. Bergstrom will reach out to Gretchen at Northwest Regional Planning Commission for any feedback to the Town Plan Draft 2.0 before revising for the Selectboard and the next phase of Public Hearings.
- C. Development Regulation Review, if time allows
  - Planning Commission members will continue to examine the current Development Regulations and bring ideas for edits and revisions to the next meeting.
