Application for Boring Under, Digging across a Town Road or Excavation in a Town Right of Way

The Town of Georgia requires all parties to obtain a permit prior to boring under a Town road, digging across a Town road or excavating in the Town Right Of Way. The application must be submitted to the Public Works Director for review at least 10 business days prior to the proposed date of construction.

Overhead installation or boring under the road bed are the preferred methods for the installation of utility lines. At the time of this application review, a plan on how this construction will be performed must be attached. Efforts should be made to keep one side of the roadway passable at all times with traffic flow interruptions kept to less than 10 minutes.

1. A deposit of \$5,000.00 for blacktop roads and \$2,500.00 for gravel roads must be posted at the time of approval. The Town of Georgia will hold this deposit in Escrow. At the time of project completion, the quality of the road must be as good as or better than its prior condition as determined by the Public Works Director. After one year of the excavation, the Public Works Director will determine the condition of the road. For gravel roads all funds not expended in stabilizing the site will be reimbursed to the applicant. For paved roads 50% of the funds not expended in stabilizing the site will be reimbursed to the applicant. The remaining 50% not expended in stabilizing the site will be reimbursed to the applicant after year two. All VOSHA and OSHA safety procedures must be followed. The Public Works Director, at his discretion, may request an independent site evaluation by a licensed engineer at the applicant's expense. The Town of Georgia assumes no responsibility for damage to structures placed in the right-of-way.
