

ORDINANCE NO. 2022.07.12.____

AN ORDINANCE AMENDING THE CITY OF GLEN ROSE CODE OF ORDINANCES, CHAPTER 4.05.034 FARMERS MARKET; PROVIDING FOR REPEALING, SEVERABILITY AND PROPER NOTICE, MEETING AND QUORUM CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Glen Rose, Texas (City) is a Type A general-law municipality located in Somervell County, created in accordance with the provisions of Chapter 6 of the Texas Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

WHEREAS, the City previously adopted Article 4.05 *Vendors, Peddlers, Hawkers, Solicitors* to regulate vendors, peddlers, hawkers, solicitors, and canvassers, to register vendors, itinerant vendors, and hawkers and to protect the peace, safety, and privacy of homeowners by limiting the hours of access to residential properties and establishing a “no visit” list; and

WHEREAS, Chapter 4.05.034 *Farmers Market* outlines the basic details of the Glen Rose Historic Farmers Market; and

WHEREAS, the City Council wishes to amend Chapter 4.05.034 to allow for the adoption and revision of the Glen Rose Historic Farmers Market Vendor Application and Rules and Regulations, as well as to correct typographical errors found within the ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLEN ROSE, TEXAS:

SECTION 1

INCORPORATION OF RECITALS

The above recitals are found to be true and correct and are incorporated into the body of this Ordinance as if copied in their entirety.

SECTION 2

AMENDMENTS TO CHAPTER 4.05.034 FARMERS MARKET

The following amendments are hereby adopted.

4.05.034(a) The Glen Rose Historic Farmer~~s~~ Market is located on Elm Street in the parking area adjoining the historic courthouse square.

4.05.034(d) Vendors may not utilize any electrical outlets on the square without ~~expressed~~ written permission from the city.

4.05.034(e) All vendors wishing to participate in the Glen Rose Historic Farmers Market must complete the Vendor Participation Application and adhere to the approved Rules and Regulations. The City Council may amend these documents at any time.

SECTION 3

SAVINGS/REPEALING CLAUSE

Chapter 4 of the City’s Code of Ordinances shall remain in full force and effect, save and except as amended by this or any other ordinance. All provisions of any ordinance in conflict with this Ordinance

are hereby repealed to the extent they are in conflict. Any remaining portions of said ordinances shall remain in full force and effect.

**SECTION 4
SEVERABILITY CLAUSE**

Should any section, subsection, sentence, clause, or phrase of this Ordinance be declared unconstitutional, illegal, or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. Glen Rose hereby declares that it would have passed this Ordinance, and each section, subsection, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, and phrases be declared unconstitutional or invalid.

**SECTION 5
PROPER NOTICE, MEETING, AND QUORUM CLAUSE**

It is hereby officially found and determined that the meeting at which this Ordinance was adopted by majority vote of the City Council of the City of Glen Rose, Texas was open to the public; that public notice of the time, place, and purpose of the meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code; and, that a quorum was present pursuant to Section 22.039 of the Texas Local Government Code.

**SECTION 6
EFFECTIVE DATE**

This Ordinance shall become effective immediately after its passage.
