## INTERLOCAL COOPERATION AGREEMENT

## for

## MATCHING FUNDS FOR GLEN ROSE ISD SRTS/TA PROJECT

THIS AGREEMENT is made and entered into by and between the COUNTY OF SOMERVELL, hereinafter referred to as "County", GLEN ROSE INDEPENDENT SCHOOL DISTRICT, hereinafter referred to as "GRISD", and the CITY OF GLEN ROSE, a General Law City, located in Somervell County, Texas, hereinafter referred to as "CITY".

## **RECITALS**

**WHEREAS**, the City, GRISD, and County believe it to be in the best interest of our school children to provide them with safe routes to school;

**WHEREAS**, in January of 2019 the City, GRISD, and County entered into an Interlocal Cooperation Agreement whereby the parties agreed that the City would work with a Grant Administrator to submit an application for a Safe Routes to School/TA Grant and that the covenanting parties would share the costs associated with preparing and filing said application;

WHEREAS, a Safe Routes to School/TA Grant application with a total project cost of \$1,135,172.00 (one million one hundred thirty-five thousand one hundred seventy-two dollars) was prepared and submitted on behalf of the City by Traylor & Associates, Inc.;

WHEREAS, the City received letter dated May 12, 2020 from Eric Gleason, Director Public Transportation Division of TxDOT stating that the "City of Glen Rose on the project named Glen Rose ISD SRTS/TA that has been identified for inclusion on the Conditional Projects Lists for anticipated FY21 – FY22 Transportation Alternatives Set-Aside funding";

**WHEREAS**, based on the application that was filed, \$227,034.00 (two hundred twenty-seven thousand and thirty-four dollars) in local matching funds will be required for said project.

**NOW THEREFORE**, for and in consideration of the mutual promises, covenants, and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the City, County, and GRISD hereby agree as follows:

- 1. If and when the Glen Rose ISD SRTS/TA project is approved for funding by TxDOT, the City agrees to execute a contract with TxDOT for said project as described in the Glen Rose ISD SRTS/TA application signed by Mayor Pam Miller and dated March 28, 2020.
- In exchange for the City's promises and covenants as set forth above, the County and GRISD
  each agree to provide one-third of the local matching funds required for said project. The total
  amount of the required matching funds shall not exceed \$227,034.00 (two hundred twenty-

seven thousand and thirty-four dollars). The share of each of the three covenanting parties shall not exceed \$75,678.00 (seventy-five thousand six hundred seventy-eight dollars).
