- 4. Develop preliminary map of kiosk locations.
- 5. Physically mark the kiosk locations for staff review.
- **6.** Deliver prototype of kiosk to city.
- 7. Begin fabrication of kiosks upon approval of program.
- 8. Install kiosks.
- Market program to local businesses.

SIGNATURE OF AUTHORIZED REPRESENTATIVE:

This Kiosk Order Form and Contract is a binding agreement between Lessee and Baker-Clearview Operating, LLC (Lessor) for the design, manufacture, production, and installation, of Kiosk Directional Panels (panels) to be located on Lessor's Kiosk program located in the City of Glen Rose. By virtue of Lessee's execution of this order form, Lessee authorizes Lessor to manufacture and install kiosk panels at various locations throughout the City of Glen Rose as described in the numbered kiosk locations below on this list. The term of this agreement is for a 6 month period commencing upon installation of the panel(s). At the end of the initial 6 month period this agreement will continue month to month until Lessee notifies Lessor of their intent to terminate. Lessee agrees to provide Lessor with 30 days written notice in advance of their intent to cancel this agreement. The monthly advertising rate PER SINGLE PANEL is \$50.00 WHICH IS FOR ONE PANEL ON ONE SIDE OF A STRUCTURE. The rate for a DOUBLE HEIGHT PANEL available only on Corridor Kiosks is \$75.00 PER MONTH WHICH IS FOR ONE PANEL ON ONE SIDE OF A STRUCTURE. Rent is due by the 15th of the first month indicated on the respective invoice. All sign materials are, and remain the property of Lessor. This lease is entered into by Lessee and Lessor upon the condition that it's performance hereunder shall be subject to war, strikes, uncontrollable delays in manufacture and transits, acts of God, government regulations, or other events suffered by Lessor. All of the terms and conditions hereof shall be binding upon the successors, assigns and legal representatives of the respective parties hereto. All advertising copy shall be in conformance with specifications prescribed by the City of Glen Rose. Assignment or transfer of this agreement by Lessee shall not relieve Lessee of their obligations under this agreement. In the event there is an unremedied breach of the Agreement For Services between Lessor and the City of Glen Rose, this agreement automatically reverts and assigns to the benefit of the City of Glen Rose according to the terms and conditions set forth in same Agreement For Services.

The color of all kiosk sign structures and panel background color will be approved by the city and shall be of a uniform design. Sign panels will contain the name of a local business, subdivision, builder or neighborhood along with a directional arrow or directional copy. Lessor agrees to maintain Lessee's advertising panels in excellent condition throughout the term of this agreement.


