## **REGULAR CITY COUNCIL MEETING**

The City Council of the City of Glen Rose met in a Regular Meeting on Tuesday, March 12, 2024 in the Glen Rose City Hall, Council Chambers, 201 NE Vernon, Glen Rose, TX 76043 at 5:30 PM to consider the following items of business:

Mayor Joe Boles called the meeting to order at 5:30 p.m.

#### PUBLIC HEARING

- Public hearing regarding a Preliminary Plat for Creekside Addition, a proposed 22-lot subdivision, being 5.400 acres out of the Milam County School Land Survey, Tract C4-1, accessible by North English Street and Texas Drive, and being identified by the Somervell Central Appraisal District as Parcel No. R1062 in the City of Glen Rose, Somervell County, Texas Mayor Boles opened the public hearing at 5:33 p.m. No one came forward to speak in favor of or opposition to the preliminary plat. Mayor Boles closed the public hearing.

Glenn Wilson, owner, explained to Council his desire to have his property annexed into the City of Glen Rose. Todd Massey, owner of Massey's BBQ, which currently occupies the property, was in attendance and thanked Council for the warm welcome to the community.

- 7. Discussion, consideration, and possible action regarding the implementation of time-limit parking on Vernon Street between Walnut and Elm Streets, Monday-Friday, between 8 a.m. and 5 p.m., excluding holidays

MOTION by George Freas, second by TJ Walker, to send a letter on behalf of the City Council asking the Somervell County employees to leave the parking in this area free for customers, especially those with mobility issues. MOTION CARRIED by unanimous vote.
