# MINUTES OF THE CITY OF GLEN ROSE REGULAR CITY COUNCIL MEETING

The City Council of the City of Glen Rose met in a Regular Meeting on Tuesday, January 14, 2025, in the Glen Rose City Hall, Council Chambers, 201 NE Vernon, Glen Rose, TX 76043, at 5:30 PM to consider the following items of business:

#### **CALL TO ORDER**

Mayor Joe Boles called the meeting to order at 5:30 p.m.

#### **INVOCATION**

Mayor Boles led the invocation.

#### **PLEDGES OF ALLEGIANCE**

### **ANNOUNCEMENTS AND PRESENTATIONS**

- 1. Presentation from Michaella Rambler regarding the Glen Hotel
  Michaella gave an overview of the Glen Hotel project, which has a projected soft opening in quarter
  three of 2026. She reviewed the hotel's current conditions, including water damage to the roof. She
  wants to ensure that the project pays homage to the building's history and seeks the City of Glen Rose's
  support for the restoration.
- 2. Presentation from the Next Move Group
  - The Next Move Group presented a strategic and vision plan for future economic development to find alternative funding sources for the projects. They explained the need to diversify the economy by expanding the industrial park and vacant 5-acre tract to support a facility employing 100-200 people. They also reviewed the housing situation in Glen Rose and the number of homes needed to support incoming residents.
- 3. Presentation of recent hydrogeological evaluation findings by engineer Chris Hay

Chris Hay from EHT gave a presentation on the groundwater study and its future capacity. He highlighted that the executive summary gave the main points of the study and that the wells alone can not supply the current needs. Glen Rose could not rely on groundwater alone but could meet demand with the water district.

Sarah De La Garza (Chamber), JC Stone (Hotel), Melissa Pew (Short-term Rental), Karen Wells (Hotel), and Autumn Easterwood Anderson (Relator) were appointed to the board without a vote.
