

**ORDINANCE # \_\_\_\_\_**

**AN ORDINANCE OF THE CITY OF GLEN ROSE, TEXAS, AMENDING ARTICLE A.5000, DIVISION 2 “SANITATION SERVICE,” SEC. A5.031 “RATES” OF THE CITY’S CODE OF ORDINANCES TO INCREASE RATES TO REFLECT AN INCREASE IN THE RATES REPUBLIC SERVICES IS CHARGING THE CITY; PROVIDING REPEALING, SEVERABILITY, PROPER NOTICE, MEETING AND QUORUM CLAUSES; AND AN EFFECTIVE DATE.**

**WHEREAS**, on December 10, 2021 the City received notification from Republic Services of a 6% rate increase for the municipal solid waste collection services being provided to the City of Glen Rose (City) pursuant to the provisions of Section 10 of the Contract and subsequent Amendment;

**WHEREAS**, the rates the City has been charging its customers for municipal solid waste collection services to cover the Republic charges and the City’s overhead are only 5% higher than the rates being charged by Republic Services;

**WHEREAS**, if the City doesn’t increase customer rates, it will experience a loss every month on the municipal solid waste collection services it is providing;

**WHEREAS**, after considering the matter, the City Council has determined for the good government, peace, and order of the municipality, to increase the City’s municipal solid waste collection rates by amending Article A.5000, Division 2, “Sanitation Service,” Sec. A5.031 “Rates” of the City’s Code of Ordinances to reflect a \_\_\_\_% increase in its municipal solid waste collection rates;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLEN ROSE, TEXAS:**

**SECTION 1 (OF 9)  
INCORPORATION OF RECITALS**

All of the above recitals are found to be true and correct and are incorporated into the body of this Ordinance as if copied in their entirety.

**SECTION 2 (OF 9)  
AMENDING SECTION A5.031 “RATES”**

Section A5.031 “Rates” of the City’s Code of Ordinances shall be amended to read as follows:

**SECTION 6 (OF 9)  
SAVINGS/REPEALING CLAUSE**

Article A.5000 “Utility Rates and Charges” of the City’s Code of Ordinances shall remain in full force and effect, save and except as amended by this or any other ordinance. All provisions of any ordinance in conflict with this Ordinance are hereby repealed to the extent they are in conflict. Any remaining portions of said ordinances shall remain in full force and effect.

**SECTION 7 (OF 9)  
SEVERABILITY CLAUSE**

Should any section, subsection, sentence, clause or phrase of this Ordinance be declared unconstitutional, illegal or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Ordinance shall remain in full force and effect. Glen Rose hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional or invalid.

**SECTION 8 (OF 9)  
PROPER NOTICE, MEETING, AND QUORUM CLAUSE**

It is hereby officially found and determined that the meeting at which this Ordinance was adopted by majority vote of the City Council of the City of Glen Rose, Texas was open to the public; that public notice of the time, place, and purpose of the meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code; and, that a quorum was present pursuant to Section 22.039 of the Texas Local Government Code.

**SECTION 9 (OF 9)  
EFFECTIVE DATE**

This Ordinance shall take effect immediately from and after its passage and publication.
