CONTRACT AMENDMENT

Knox Waste Service (hereinafter called "Contractor") and the City of Glen Rose (hereinafter called "City") with continued service provided under the original CONTRACT FOR DISPOSAL OF NON-HAZARDOUS WASTE executed on October 16, 2017, agree to the following amendments:

Page one, #3: Replace the whole existing sentence with: "The primary term of this contract shall commence on January 1, 2018 and shall expire at midnight on December 31, 2022, however, in the event neither part hereto provide the other with written notice of termination of this contract more than ninety (90) days prior to December 31, 2022, this contract shall automatically extend for an additional four (4) year period following the end of primary term."

Page three, #10: Under "MONTHLY FEES," replace "95 gallon cart twice a week \$17.95" with "95 gallon cart once a week \$9.95" and replace "Additional cart \$8.00" with "Additional cart \$7.00". Under "ROLL OFFS: For the City of Glen Rose" replace "twenty-four (24) 30 yard roll off containers" with "twelve (12) 30 yard roll off containers". Below "ROLL OFFS: For the City of Glen Rose," add the following new section:

BI-ANNUAL BULK CURBSIDE PICKUP

At no charge to the City or its citizens, the Contactor shall provide bi-annual bulk curbside pickup within the City on dates agreed to by the City and the Contractor and subject to the following conditions:

Bulk pick up guidelines:

The City will provide the Contractor in advance of a bulk pick up event, a list of addresses

that bulk pick up has been requested.

Bulk items accepted:

All types of refuse and wastes that would normally be associated with maintaining a residence, such as chairs, tables, couches, lamps, stereos, televisions, old clothing, boxes, etc., water heater, clothes washer/dryer, dishwasher. Grass trimmings, leaves and debris bagged in no bigger than a 30-gallon trash bags. Brush must be bundled no longer than 4 feet in length and 3 feet in diameter.

Items NOT accepted in bulk pickup are, but not limited to: items that contain gaseous refrigerants, demolition/remodeling materials such as lumber, sheet rock, shingles, siding, concrete, tires etc.


Page five, #19: Replace "cure period specified in the terms of this contract." with "cure period of two (2) business days."

The once a week pick-up schedule will become effective April 1, 2019. All other terms as contained in the original contract dated October 16, 2017 remain in full force and effect. The parties signing this amendment represent to have the authority on behalf of their respective organization to enter into this agreement.
