SUMMARY:

The Crime Control and Prevention District (CCPD) has a board of directors comprised of seven members appointed by City Council. Historically, the City Council has elected to appoint City Council members, with the exception of the Mayor and Mayor Pro Tem, to serve as the CCPD board of directors. New appointments must be made prior to September 1st of each year, and all vacancies are filled for the remainder of the existing term. The proposed board of directors and associated term expiration dates for the Grand Prairie Crime Control and Prevention District are:

A RESOLUTION OF THE CITY OF GRAND PRAIRIE, TEXAS, REMOVING AND APPOINTING GRAND PRAIRIE CRIME CONTROL AND PREVENTION DISTRICT BOARD OF DIRECTORS

WHEREAS, the Citizens of Grand Prairie voted to create the Grand Prairie Crime Control and Prevention District (CCPD); and

WHEREAS, the Grand Prairie City Council is responsible for appointing the CCPD board of directors; and

WHEREAS, the term for three members of the board of directors is set to expire September 1, 2026; and

WHEREAS, the council desires to remove and replace one member of the CCPD board of directors.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS, THAT:

SECTION 1. Mike Del Bosque is deceased and is thereby removed from his position as a board of director for the Grand Prairie Crime Control and Prevention District, and David Chappelle is appointed for the remainder of his term which expires September 1, 2027.

SECTION 2. Kurt Johnson is removed from his position as a board of director for the Grand Prairie Crime Control and Prevention District, and Rodney Anderson is appointed for the remainder of his term which expires September 1, 2026.

SECTION 3. Jorja Clemson, Tony Shotwell, and Rodney Anderson are appointed to fill the vacancies on the Grand Prairie Crime Control and Prevention District Board which are created by the terms expiring September 1, 2026, with said new terms expiring September 1, 2028.
