PURPOSE OF REQUEST:

The Transportation and Mobility Department is requesting the services offered by Roadway Asset Services, LLC (RAS) related to the pavement and asset management needs of the City of Grand Prairie. RAS, a Texas engineering firm, provides engineering, surveying, asset management, transportation planning, and Geographic Information System (GIS) services.

Chapter 271.102 of the Local Government Code authorizes local governments to participate in a cooperative purchasing program with another local government or local cooperative organization. In lieu of competitive bidding, items and services may be purchased through such agreements as the agreements have already been bid on by the sponsoring entity or agency.

AN ORDINANCE OF THE CITY OF GRAND PRAIRIE, TEXAS, AMENDING ORDINANCE NO. 11602-2024 FOR THE FY 2024/2025 CAPITAL IMPROVEMENT PROJECTS BUDGET BY TRANSFERRING AND APPROPRIATING \$450,000 FROM THE UNOBLIGATED FUND BALANCE IN CAPITAL RESERVE FUND TO STREET CIP FUND FOR STREET ASSESSMENT STUDY FOR ALL EXISTING CITY ROADS

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS, THAT:

SECTION 1. The FY 2024/2025 Street CIP Fund budget is hereby incrementally amended by transferring and appropriating \$450,000 from the unobligated fund balance in the Capital Reserve CIP Fund to the Street CIP Fund to the Street Assessment Study for All Existing City Roads project.
