LEGAL DESCRIPTION
TEMPORARY CONSTRUCTION EASEMENT

BEING a 50 foot wide strip of land located in the JOSEPH STEWART SURVEY, Abstract No. 961, Ellis County, Texas, and being a portion of the tract of land conveyed to PRA Prairie Ridge Development Corp., by the deed recorded in Volume 2325, Page 470, of the Deed Records of Ellis County, Texas. Said 50 foot wide strip of land being more particularly described by metes and bounds as follows:

THENCE S 30° 09' 39" E 41.91 feet, along the Northeast boundary line of said PRA Prairie Ridge Development Corp. Tract, to a point;

THENCE S 60° 20' 04" W 618.65 feet, to a point;

THENCE N 30° 05' 36" W 50.00 feet, to a point;

THENCE N 60° 20' 04" E 568.40 feet, to a point lying in the Northeast boundary line of aforesaid PRA Prairie Ridge Development Corp. Tract;

THENCE S 29° 57' 58" E 9.00 feet, to a point;

THENCE N 59° 17' 44" E 50.23 feet, to the POINT OF BEGINNING containing 0.700 acre (30,502 square feet) of land.

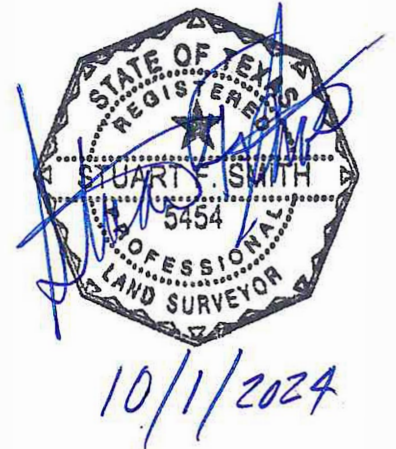

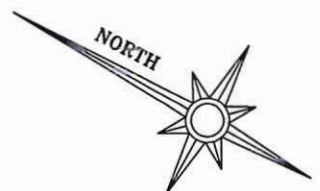

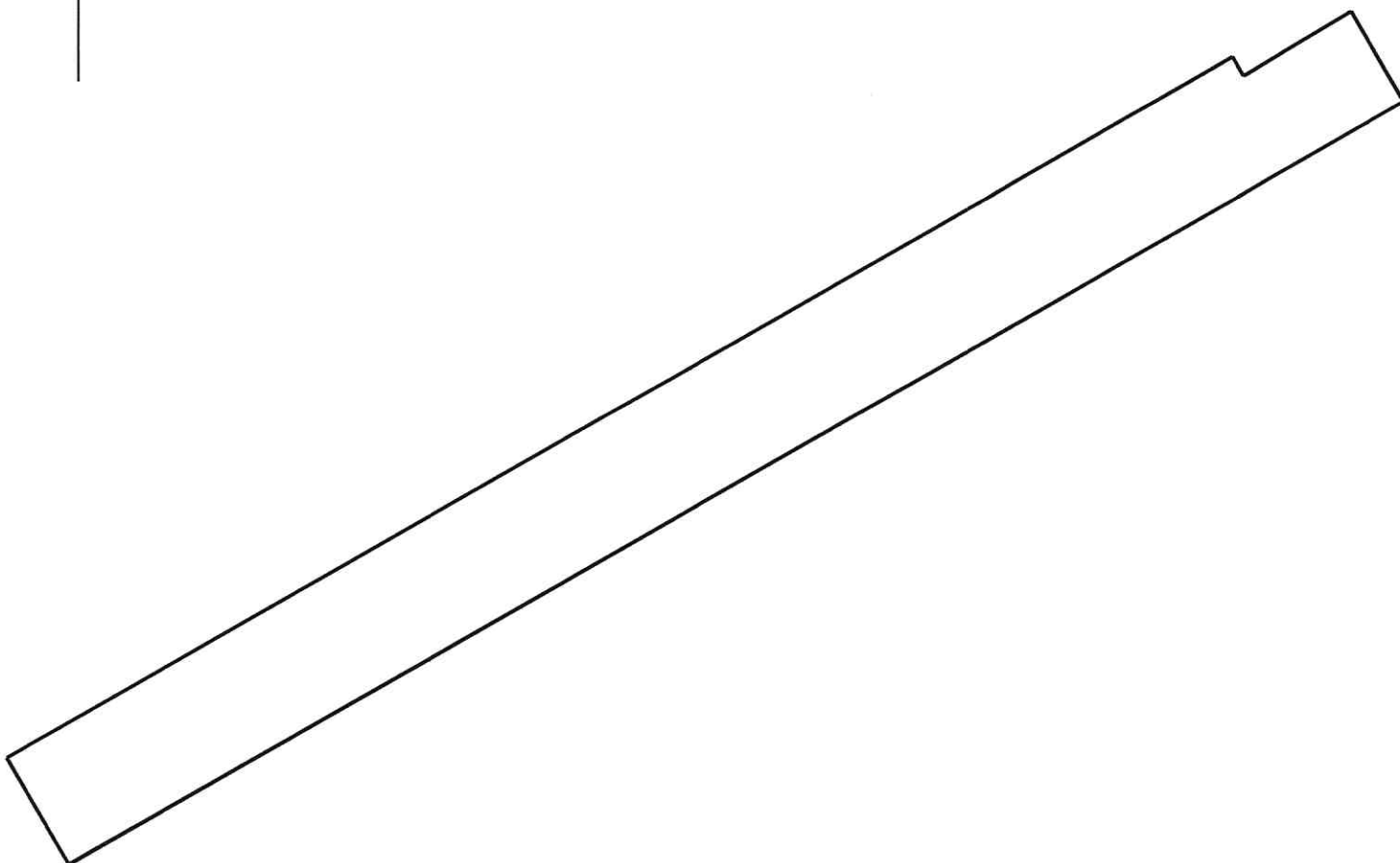
