PURPOSE OF REQUEST:

The Solid Waste and Recycling Department is seeking to apply for funding to host a tire collection event at the landfill.

The NCTCOG Environment and Development department has allocated funding for sponsoring tire collection events across the North Central Texas region. Cities and counties can either host an event for residents or collect tires from an illegal dump site on public property. All events and cleanup activities must be complete by March 28, 2025. This opportunity will operate on a first-come, first-serve basis.

FINANCIAL CONSIDERATION:

The amount of funding requested for the tire collection event is \$2,875. Tires collected at the event will be recycled by our current vendor 'All American Tire Recyclers' through our existing contract. At the conclusion of the event, a reimbursement request must be submitted to NCTCOG.

BODY

A RESOLUTION OF THE CITY OF GRAND PRAIRIE, TEXAS, AUTHORIZING THE FILING OF A PROJECT APPLICATION WITH THE NORTH CENTRAL TEXAS COUNCIL OF GOVERNMENTS FOR A TIRE COLLECTION EVENT AT THE LANDFILL FOR THE AMOUNT OF \$2,875; AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE, TO ACT ON BEHALF OF THE CITY OF GRAND PRAIRIE IN ALL MATTERS RELATED TO THE

APPLICATION; AND PLEDGING THAT IF FUNDING FOR THIS PROJECT IS RECEIVED, THE CITY OF GRAND PRAIRIE WILL COMPLY WITH ALL PROJECT REQUIREMENTS OF THE NORTH CENTRAL TEXAS COUNCIL OF GOVERNMENTS

WHEREAS, the North Central Texas Council of Governments (NCTCOG) is directed by the Texas Commission on Environmental Quality (TCEQ) to administer solid waste project funds for the implementation of NCTCOG's adopted Regional Solid Waste Management Plan; and

WHEREAS, the City of Grand Prairie in the State of Texas is qualified to apply for project funds under the Request for Project Applications.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS THAT:

SECTION 1. The City Manager or his designee is authorized to request grant project funding under NCTCOG's Regional Tire Collection Event Funding and act on behalf of City of Grand Prairie in all matters related to the grant project application and any subsequent project contract that may result.

SECTION 2. If the grant project is funded, The City of Grand Prairie will comply with the requirements of NCTCOG, TCEQ and the State of Texas.

SECTION 3. The local government will allocate and expend the necessary monies to support this grant project and then seek reimbursement from NCTCOG on a timely basis.

SECTION 4. The grant project funds, and any project-funded equipment or facilities will be used only for the purposes for which they are intended under the project.
