PURPOSE OF REQUEST:

For a State roadway to be closed on a temporary basis to support an event that serves a public purpose, TxDOT requires the requesting city to enter into an agreement for the temporary closure. The temporary closure request is for W. Main Street (SH-180) starting on Friday, October 24, 2025, from 9 AM to 5 AM on Monday, October 27, 2025, for the Main Street Festival. The closure will be from Center Street to NW 6th Street. A detour route will be provided via N. Center Street to Hill Street to NW 6th Street.

BODY

A RESOLUTION OF THE CITY OF GRAND PRAIRIE, TEXAS, AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE STATE OF TEXAS, THROUGH THE DEPARTMENT OF TRANSPORTATION, TO CLOSE A PORTION OF SH-180 (W. MAIN STREET) ASSOCIATED WITH THE 2025 GRAND PRAIRIE MAIN STREET FESTIVAL

WHEREAS, the Texas Department of Transportation operates certain state highways within the City limits of the City of Grand Prairie; and

WHEREAS, the City of Grand Prairie requires the temporary closure of a state highway within the City of Grand Prairie; and

WHEREAS, the 2025 Grand Prairie Main Street Festival will be held on a portion of Main Street within the City of Grand Prairie with anticipated attendance of approximately 40,000 citizens, visitors, and vendors; and

WHEREAS, the temporary closure of a portion of the state highway system serves a public purpose and is necessary to protect the safety of the patrons crossing from the parking area to the festival and visiting the vendor booths in the roadway; and

WHEREAS, the Texas Department of Transportation and the City of Grand Prairie have agreed to certain terms and conditions regarding the temporary closing of a portion of the state highway system within the City of Grand Prairie limits for the purpose of said closing; and

WHEREAS, the City Council of the City of Grand Prairie has considered the foregoing and aforesaid contract and have agreed to be bound by the provisions thereof for the purpose of closing said highway for the 2025 Main Street Festival to be held October 24, 2025 to October 26, 2025. The street closure will last up to 5 AM on Monday October 27, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS THAT:

SECTION 1. The City Manager is authorized to execute an Agreement for the Temporary Closure of State Right of Way with TxDOT on behalf of the City of Grand Prairie.

SECTION 2. The project is for the closure of SH-180 (W. Main Street) from Center Street to NW 6th Street from 9 AM on October 24, 2025 to 5 AM on October 27, 2025.
