#### AGENDA REVIEW

*Mayor Pro Tem Clemson asked if Council had any questions on Consent Agenda items two through thirteen. Council Member Shotwell asked to clarify item nine. Public Health Supervisor Jody Cason provided an overview of the two charging stations and advised this grant is for charging stations for city fleet use only. Fleet Manager Colby Collins discussed the number of electric vehicles currently in fleet. Deputy City Manager Cheryl De Leon noted future options on vehicle types are being reviewed. General Services Director Jayson Ramirez said chargers located at City Hall and Epic Central are for public use and are pay per use. Council Member Lopez reminded Council this is grant money and should make use of it where possible. Council Member Headen asked to clarify item six. Transportation Director Caryl Devries said they will be rebidding the item because none of the current bidders completed the required federal forms provided in the bid packet. Council Member Adams asked to clarify item five. Ms. De Leon noted they are paid out of Hotel/Motel Tax (HOT) funds and this is the only funding they receive. Mayor Jensen noted item eighteen will be tabled to the next meeting and Council Member Lopez confirmed same.*

**PLANNING AND ZONING FOR INDIVIDUAL CONSIDERATION**

15. STP-24-07-0032 - Site Plan - Goodland Villages - Phase 1 (City Council District 6). Site Plan for a residential development with 54 Single Family Detached units and 122 Single Family Attached units on 34.86 Acres. Portions from two parcels (Parcel IDs 190600 & 284558) out of JOS Stewart Survey, Abstract No. 961, City of Grand Prairie, Ellis County, zoned PD-455, generally located south of Prairie Ridge Blvd and west of Old Fort Worth Rd (On December 9, 2024, the Planning and Zoning Commission recommended approval with conditions by a vote of 9-0)

*Harold Willis, 538 Lindly, recorded his support of this item.*

*Chief City Planner Savannah Ware started the presentation, and Council Member Johnson advised he has received sufficient information. He then moved, seconded by Council Member Del Bosque, to approve this item as presented by staff. The motion carried unanimously.*

## PUBLIC HEARING ZONING APPLICATIONS

16. ZON-24-09-0023 - Zoning Change/Concept Plan - Cell Tower at 1355 E Seeton Rd (City Council District 6). Amendment to PD-318B to allow a Cell Tower within PD-318B with City Council approval of a Specific Use Permit and to adopt a Concept Plan depicting the Cell Tower location. Lot 1, Block 1, CRC Mira Lagos Addition, City of Grand Prairie, Tarrant County, Texas, zoned PD-318B, within Lake Ridge Corridor Overlay, with an approximate address of 1355 E Seeton Rd (On December 9, 2024, the Planning and Zoning Commission recommended approval by a vote of 9-0)

*Ms. Ware advised items sixteen and seventeen would be presented together. Council Member Johnson noted a presentation is not necessary as he received information and has heard from several constituents. Planning and Development Director Rashad Jackson advised the property owner is contracting with the applicant. There was discussion on Verizon owning the towers and the city receiving no funding for this project.*

*Harold Willis, 538 Lindly, spoke in opposition of this item and item seventeen.*

*Alec Broadus, 4 Country Place Cir, Dalworthington Gardens, spoke in support of this item and item seventeen. He discussed his experience in communications and with cell towers. Mr. Broadus noted cell phone coverage is not adequate in this area, and the church and Verizon have agreed to a deal. He said he spoke with the Homeowners Association (HOA), and they approve and said the item was reviewed by the Planning and Zoning Commission (P&Z) who recommended approval. Mr. Broadus said community members were canvassed and there were seventeen no's and zero yeses, there are 300 others who have not come forward. He also said additional homes are being built and if this is not approved, services will not get better. Council Member Johnson said there is not 100% community support, discussed the item being tabled twice at the applicant's request, and noted he is a council member responsible for responding for the people in the community.*

*Mike Grissom, 7655 Watercrest Ln, spoke in opposition of this item and item seventeen. Mr. Grissom said he opposes the cell tower and speaks for his neighbors and HOA. He discussed the flyer left by Mr. Broadus and said he attended both area meetings. Mr. Grissom discussed the environmental safety hazard concerns for 5G cell antennas. He said the tower will have a negative impact on home sales, and loss of property evaluation. Mr. Grissom discussed cell phone service, responsibility for maintenance and the church receiving a large amount of funds for this deal. Council Member Shotwell asked to review the location of tower and Mr. Ware reviewed the site plan and elevations.*

*Council Member Johnson moved, seconded by Council Member Del Bosque, to deny items sixteen and seventeen. The motion carried unanimously.*

December 9, 2024, the Planning and Zoning Commission recommended approval by a vote of 9-0)

18. SUP-24-10-0045 - Specific Use Permit - Flex-N-Gate Private Fuel Station (City Council District 4). Specific Use Permit for a Private Fuel Station at an existing industrial development. Lot 1R, Block D, Bardin Road Addition, City of Grand Prairie, Dallas and Tarrant Counties, Texas, zoned PD-372, within the IH-20 Corridor Overlay District, and located at 2150 W Bardin Rd (On December 9, 2024, the Planning and Zoning Commission recommended approval by a vote of 8-1)

*Council Member Lopez said this was discussed at Briefing. He then moved, seconded by Council Member Headen to table this item. The motion carried unanimously.*
