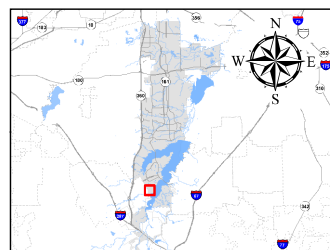

Additional Comments

We are writing to express our strong opposition to the proposed construction of a new cell tower in our community, specifically behind Rush Creek Church off Seeton Rd. This decision could have significant adverse health impacts on our population, particularly on children, women, and men residing in the vicinity. Here are the key reasons for our concern:

Health Risks Associated with Radiofrequency Radiation (RFR)

1. Cancer Risk:

Research has shown an increased risk of uncommon heart tumors called malignant schwannomas in male rats exposed to RFR levels comparable to those emitted by cell towers 5.

A comprehensive review of 38 studies found that 73.6% showed effects, including a 76.9% association with cancer 7.

2. Neurological and Behavioral Effects:

Studies have reported symptoms like headaches, memory changes, dizziness, tremors, depressive symptoms, fatigue, and sleep disturbances in populations near cell towers 410.

A review of 100 studies found approximately 80% showed biological effects near towers, including neurophysiological effects 4.

3. Reproductive and Developmental Impacts:

There is evidence suggesting that RFR exposure could negatively impact male fertility, with studies showing effects on sperm quality 3.

While the evidence on pregnancy outcomes is mixed, some studies indicate potential risks for miscarriage, congenital malformations, low birth weight, and preterm birth 3.

Case Studies Highlighting Health Concerns

Case Study 1: Development of Microwave Syndrome

In a study published by Hardell and Nilsson (2023), two individuals

developed symptoms of microwave syndrome after a 5G base station was installed on the roof above their apartment. Symptoms included neurological issues, tinnitus, fatigue, insomnia, emotional distress, skin disorders, and blood pressure variability 4.

Case Study 2: Increased Cancer Incidence

A study by Dode et al. (Brazil) found an increased prevalence of adverse neurobehavioral symptoms and cancer in populations living within 500 meters of cell towers. This study suggests that current international guidelines may not adequately protect human health 4.

Regulatory and Scientific Consensus

The International Agency for Research on Cancer (IARC) has classified RFR as "possibly carcinogenic to humans" 5.

Despite regulatory bodies like the FCC and ICNIRP setting exposure limits based on thermal effects, there is mounting evidence of non-thermal effects causing adverse health outcomes 11.

The World Health Organization (WHO) has identified cancer, adverse reproductive outcomes, cognitive impairment, symptoms, oxidative stress, and heat-related effects as priority topics for further research due to potential health risks 3.

Conclusion

Given the substantial scientific evidence linking RFR exposure to various health issues, including cancer, neurological disorders, and reproductive health concerns, we urge the city to reconsider the approval of this cell tower. The health and well-being of our community, especially our children, should not be compromised for the convenience of industry.
