#### **PURPOSE OF REQUEST:**

This contract provides Professional Engineering Services for the design, bidding, construction plans, topographic survey and other reimbursable expenses of various Street Services and other department projects on roadways, bridges, guardrails and storm drains.

Request for Qualification (RFQ) #24199 was advertised in the Fort Worth Star-Telegram and Planet Bids; it was sent to 1,535 vendors, 1,372 of which are Historically Underutilized Business (HUB)/Minority Women Owned Business Enterprise (MWBE) and 5 are local vendors.

Cobb, Fendley & Associates, Inc. engineering firm was selected as primary and Parkhill, Smith & Cooper, Inc. dba Parkhill as secondary after review and scoring of their qualifications and experience.
