TITLE: Resolution ratifying a FY 2025 CI-Byrne State Crisis Intervention Program application for the Office of the Governor, Public Safety Office, for the purpose of funding a Crisis Support Specialist position's annual salary, fringe benefits and training in the amount of \$89,740.00, and authorizing the City Manager to accept, reject, alter or terminate the grant, if awarded

PURPOSE OF REQUEST:

The Grand Prairie Police Department is proposing the addition of a fourth Crisis Support Specialist position to serve specialized populations within the community. The specialized populations include group home residents suffering from mental health and intellectual developmental disabilities (IDD) and persons experiencing homelessness.

There is an increased number of group homes and homeless community members in Grand Prairie, and adding a fourth Crisis Support Specialist dedicated to providing essential related services to these populations will allow for timely follow-up and continuity of care for these community members.

FINANCIAL CONSIDERATION:

This grant does not require a cash or in-kind match.

WHEREAS, if the grant is awarded, the City will have limited time to accept the grant; and

WHEREAS, the grant requires grant funds to be returned in the event of loss or misuse of program funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GRAND PRAIRIE, TEXAS, THAT:

SECTION 1. The City Council of the City of Grand Prairie, Texas hereby supports and ratifies grant application number 5239901 for the State Crisis Intervention Grant Program from the Office of the Governor, Public Safety Office, in the amount of \$89,740.00.

SECTION 2. The City Manager of the City of Grand Prairie is empowered to accept, reject, alter, or terminate this grant on behalf of the City Council.

SECTION 3. The funds will be returned to the Office of the Governor, Public Safety Office in the event of loss or misuse of program funds.

SECTION 4. This resolution shall be in full force and effect from and after its passage and approval in accordance with Charter of the City of Grand Prairie and it is accordingly so resolved.
