TITLE: Award a disaster debris monitoring contract to DebrisTech in an

amount not to exceed \$300,000, total award will not exceed \$1,500,000 if all four extensions are exercised; the contract will be for an initial term of one year with the option for four one-year renewals and authorize the City manager to execute the renewal options on the

contract.

PURPOSE OF REQUEST:

These estimated costs associated with this contract were derived using a hypothetical storm event with a set amount of work hours to be performed. Actual costs will depend upon the scope of monitoring work to be provided for a large-scale debris-generating event. This price agreement will only be used in the event of a large-scale debris-generating disaster.

Within the last three years, the mid-west has seen several catastrophic storm events that have produced large quantities of disaster debris. Each of these events has produced an unanticipated amount of construction and demolition waste, household hazardous waste, vegetative debris and appliances. These events can cost a community millions of dollars in unplanned expense, but a significant portion of it, if handled in accordance with Public Assistant directives, are reimbursable. Were Grand Prairie to experience such a storm, the city would need to respond quickly to questions of how to best handle the additional storm-generated materials and how to do so in the most fiscally responsible manner.

City Staff requested proposals from qualified and experienced contractors for a stand-by contract for disaster debris hauling in the event of a natural or man-made disaster as directed by the City in order to eliminate immediate threat to the public health and safety. Disaster debris monitoring services, if activated, would efficiently monitor the removal of large volumes of disaster-generated waste from a large area in a timely and cost-effective manner. Due to Federal Emergency Management Agency (FEMA) requirements, hauling and monitoring must be awarded to two separate contractors.

The contract will be for an initial term of one year with the option for four one-year renewals. Each term the contract value would be for an amount not to exceed \$300,000, prepositioned and ready should we ever need disaster debris monitoring services.

DebrisTech meets all specifications and are recommended for award.

FINANCIAL CONSIDERATION:

All of the City's property and assets are currently insured through the Texas Municipal League (TML). However, the decision to request federal assistance comes after all local and state resources have been exhausted and an uninsured losses threshold has been exceeded. The Stafford Act states the following:

Section 401. Procedures for Declaration. All requests for a declaration by the President that a major disaster exists shall be made by the Governor of the affected State. Such a request shall be based on a finding that the disaster is of such severity and magnitude that effective response is beyond the capabilities of the State and the affected local governments and that Federal assistance is necessary. As part of such request, and as a prerequisite to major disaster assistance under this Act, the Governor shall take appropriate response action under State law and direct execution of the State's emergency plan. The Governor shall furnish information on the nature and amount of State and local resources which have been or will be committed to alleviating the results of the disaster, and shall certify that, for the current disaster, State and local government obligations and expenditures (of which State commitments must be a significant proportion) will comply with all applicable cost-sharing requirements of this Act. Based on the request of a Governor under this section, the President may declare under this Act that a major disaster or emergency exists.

Therefore, the City requires additional reviews and approvals of accessing, appropriating, and utilizing available funding until any FEMA assistance is provided. A reimbursement resolution request will be necessary to allow use of available funds such as reserves and will require repayment of such funds upon the approval of another funding mechanism, such as debt issuance.

Debt will be specific to an operation's capital needs. Depending upon the nature of the specific debris generating event, debt issuance will vary by type, structure, and dollar amount. Due to the emergency circumstances, this process would be expedited. It is estimated that debt funds may be available within 30 to 60 days or as quickly as a reimbursement resolution request could be approved by City Council.
