#### **PURPOSE OF REQUEST:**

In August 2022, City Council approved contracts with Mansfield Oil Co. of Gainesville Inc. and U.S. Energy, a Division of U.S. Venture Inc., in the amount of \$2,000,000 for an initial term of 5 months with the option to renew for two additional one-year periods (up to \$4,000,000 annually), totaling \$10,000,000 if all extensions were exercised. Both contracts were awarded through a Cooperative Contract with Omnia Partners and the City of Fort Worth as the Principal Procurement Agency for the Public Sector.

This proposed Council action is to extend each contract for an additional six-month period to coincide with City of Fort Worth/OMNIA Partners' extension of their motor fuel contracts # 53315 and 53316 that were extended through June 30, 2025. The amount for the extended term will not exceed the combined amount of \$1,700,000, for a total combined contract amount not to exceed \$11,700,000.

State Purchasing laws, Government Code, Chapter 271.102 authorize local governments to enter into joining contracts and cooperative agreements for the performance of governmental functions normally associated with the operation of government such as purchasing necessary materials and supplies.

The City approved a Cooperative Agreement with OMNIA Partners; whereby, the City could make use of all that entity's agreement(s).
