TITLE: Ordinance amending the FY2024/2025 Capital Improvement Projects Budget; Construction contract with Paragon Sports Constructors, LLC (PSC) for tennis and pickleball court construction at Friendship Park in the amount of \$522,466 plus a 5% contingency in the amount of \$26,123.30 for a total project cost of \$548,589.30 through a national cooperative agreement with Buyboard

PURPOSE OF REQUEST:

Staff is seeking approval of an agreement with Paragon Sports Constructors, LLC (PSC) for site construction of a tennis and pickleball court at Friendship Park. Construction will include demolition of existing court, earthwork, soil conditioning, concrete pads, concrete sidewalk connections, site furnishings, and landscape and irrigation.

A survey of the existing conditions was conducted by Falkofske Engineering that determined the best solution is to remove the current court and re-build in the same location with soil amendments.

The Buyboard contract number is 737-24.

Chapter 271.102 of the Local Government Code authorizes local governments to participate in a cooperative purchasing program with another local government or local cooperative organization. In lieu of competitive bidding, items and services may be purchased through such agreements as the agreements have already been bid by the sponsoring entity or agency. The City of Grand Prairie has master cooperative agreements with various entities, including Buyboard.
