  schedule an appointment, please call (218) 326-7344. If you happen to reach the main
  switchboard at Grand Itasca, please request to be transferred to Occupational Medicine. Please
  bring a copy of your job description to this appointment.
- You will need to successfully complete and pass a pre-employment psychological evaluation.
   Your pre-employment psychological evaluation will be scheduled virtually with Dr. Michael Keller, out of Cambridge, MN. I will reach out to you regarding his availability. Plan to allow two (2) hours for the evaluation.
- You will also need to stop by Northern Drug Screening located at 111 NE 10<sup>th</sup> Avenue in Grand Rapids, MN for a pre-employment drug screening. They are open Monday through Friday from 8:00 a.m. to 4:00 p.m. Please let them know you need a pre-employment drug screening for the City of Grand Rapids.
