### PRESENTATION:

Karter Starling presented to the Commission the Economic Impact of the 2024 Pride Festival, of which he included their 2024 budget, impact statements from vendors, improvement feedback and a volunteer report. Event Budget and the possibility of having banners over the highways. At this time there is not an official ask to the Human Rights Commission, but it was brought up that there may be a possibility of requesting that they serve pancakes in the morning of the event.

6. Review Draft 2025 Workplan

The Commission reviewed and discussed the 2025 Draft Workplan. The Workplan is not wet in stone, but a guide that shows where the Commission would like to contribute throughout the year. Items in the Workplan discussed were:

- Public Safety

A group from the community would like to have a conversation regarding uncomfortable issues. It would be nice to have a dialogue at an informal setting to talk about their concerns, which could be helpful to identify either international or local issues. .

##### 8. Community Education/Engagement Opportunity

Community engagement could be discussing with Dale Christy about partnering with ISD318, regarding a leadership training for the kids.

##### 9. League of MN Cities Conference

Commissioner/Councilmember MacGregor will be in Duluth for training by the League of Minnesota Cities Conference and will be doing a session on the Human Rights Commission. City Attorney Chad Sterle will also be attending the June 27th, 2025, meeting. This item will be forwarded to the April 30th, 2025, Agenda to see if anyone wants to attend the conference, they would like to know by May 1st.

##### 10. Work Groups

The Community Data Work Group did not have an update and the Juneteenth/IPDay Work Group will be meeting and Commissioners Jackson and Erickson will assist.

##### 11. Volunteers

City Liaison, City Attorney Chad Sterle discussed that there is no volunteer policy and that there are also legal considerations. There would be a vetting process because they would become a city staff member. In this day and age, the city still needs to do its due diligence, and he hoped that's understandable.

#### CALLS/COMPLAINTS/INQUIRIES:

City Liaison, City Attorney Chad Sterle stated that there was a security concern that was raised for the April 28th, City Council Meeting, regarding someone who wanted to attend that meeting, and the concern was even up to this Human Rights Meeting. Law enforcement was aware and took the individual to Vet's Services.

There were questions on why the library is not open more accessible, mainly it's hours of service. City Attorney Sterle said it's a complex issue with the State statutes and Itasca County. If Itasca County assists more, the Library could be open more often. The Library Director, Will Richter is working on this.
