### LOT DONATION AGREEMENT

THIS LOT DONATION AGREEMENT (this "Agreement") is made as of \_\_\_\_\_\_, 2023, by and between City of Grand Rapids, a Minnesota municipal corporation ("City"), and Grand Itasca Clinic and Hospital, a Minnesota nonprofit corporation ("GICH").

#### RECITALS

- A. City owns the Itasca Calvary Cemetery (the "Cemetery") located at 1700 State Highway 169 East, Grand Rapids, Minnesota.
- B. GICH has requested that City donate to GICH certain lots in the Cemetery for use as <u>infantfetal</u> burial sites by GICH patients who experience early (pre-20 week) miscarriage (collectively, the "**Donation Purpose**"), and City desires to make such donation, all subject to the terms and conditions set forth below.

## **AGREEMENT**

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, City and GICH agree as follows:

- 1. <u>Recitals; Exhibits</u>. The recitals above are true and correct, and the recitals above and the attached exhibit are incorporated herein by reference.
- 2. <u>Donation</u>. On or about the date hereof, City will transfer to GICH ownership of the six (6) lots in the Cemetery described on <u>Exhibit A</u> attached hereto (the "Lots"), at no cost to GICH and pursuant to a mutually acceptable transfer document.
- 3. <u>Lot Use</u>. GICH may use the Lots for the Donation Purpose, it being understood that each Lot may be used <u>as for multiple</u> burial sites <u>for multiple</u> infants. City will cooperate with and not charge any fees or charges to GICH or its patients for such use.
- 4. <u>Lot Maintenance/Costs</u>. While the Lots are owned by GICH, City will maintain the Lots in a manner consistent with past practice and not charge GICH or its patients any fees or charges with respect to the Lots.
- 5. <u>Future Transfers</u>. While it is the intent of the parties that the Lots be owned by GICH and used in the manner described in Section 3 above, City will cooperate with GICH if it elects to transfer ownership of any <u>unusedLot or partial</u> Lot to its patient <u>or the patient's family</u> and will take all reasonable steps necessary to facilitate such transfer, all without cost to GICH or its patient <u>or patient's family</u>. In addition, GICH may elect from time to time to transfer any unused Lot back to the City at no cost to GICH.
- 6. <u>Notices</u>. Any notice, request or other communication hereunder must be in writing (which may include email) and will be effective if sent to a party at the notice address under its signature block below or such other address as such party may provide from time to time

7. <u>Miscellaneous</u>. This Agreement may be executed in counterparts and by electronic means (including using DocuSign or through email delivery of signed signature pages). There are no third-party beneficiaries of this Agreement.
