5. Blandin Foundation Grant Discussion for 2026

The Commission discussed the Blandin Grant handout regarding the Rural Placemaking Grants (for 2026). There are three categories of rural placemaking, 1) Capacity Building-Building Placemaking Skills and Resources, 2) Planning-Planning for Placemaking Initiatives and 3) Implementation-Executing a Placemaking Initiative or Project. One of the Commissioners mentioned that they would enjoy a discussion with them at one of their upcoming meetings.

Commissioners Meittunen and Jackson would like to attend the Braver Angels Workshop which will be held on May 14th, 2025. Commissioner MacGregor will find out more on the registration for the workshop as there is a fee for attending.

Commissioner MacGregor will be attending the League of Minnesota's Annual Conference June 25-27th, 2025. She will have a short presentation on the city of Grand Rapids' Human Rights Commission and is asking for any additions to include or comments/updates from the Commissioners to be given to her by the May 28th, 2025, meeting.

## 7. Mobility Mania - Accessibility for All Event

The Commission discussed the Mobility Mania - Accessibility for All and the Judy Garland and Children's Discovery Museum event on June 19th through the 23rd, 2025. One of the Human Rights focused protected classes is Disabilities and the event highlights both disabilities and accessibility, which would be a good fit for the Human Rights Commission to sponsor this event.

Motion made by Council Representative MacGregor, Seconded by Commissioner Meittunen to sponsor the Mobility Mania-Accessibility for All and the Judy Garland and Children's Discovery Museum event on June 19th-23rd, 2025 at the "Bronze" sponsorship level of \$500.00.
