I noticed that during the remodel of the Al Tavern, at least a half dozen, if not a dozen, parking spaces are taken up daily, all day long, by

the workers that aren't really going back and forth to their trucks or utilizing their trucks for equipment, but they're just parking in that lot taking up a lot of space and we do need more disabled parking there's no doubt about that and unfortunately due to the slope of the town the topography it really has to be that one lot which now you're thinking of putting the restroom in and so it's going to be very cluttered and congested and people use that as a merry-go-round and just go around and around looking for a spot continually pulling out onto Neal Street and causing traffic issues by turning out on Neal Street and back into the lot repeatedly. People also go into that lot the wrong direction. So it needs more signage, it needs some more thought put into all this because the permit lot isn't even used across from the pioneer lot back behind the real estate office. it's mostly empty and there's a dead tree and it's trash on the ground there's a bunch of empty parking spaces so i don't understand why it is such a big deal true i don't drive currently by choice and ride a bicycle because congestion is very very bad and it's dangerous with the amount traffic and people looking for parking are distracted and going around in circles and causing a traffic issue unto themselves. So please put more thought into this because there's a lot more parking than what was just mentioned and didn't hear anything mentioned about the Richardson Street lot. That's also more level to get to Mill Street Mall if that's where you're trying to send people than either of the lower lots on the Union Square or the Pioneer Center lots. They're steeper to get up from there for the disabled folks. People use wheels, all kinds of disabilities that just the terrain keeps people literally from going where they want to go. Thank you.

I apologize for not being able to attend the meeting and submit public comment in person.

I just wanted to voice my concern regarding the proposal to implement paid parking in all of the downtown lots.

My first reaction was frustration due to the often quick trips into local businesses that just so happen to be located in the downtown area. I would be required to pay to park just to access picking up a quick to go order, or picking up bread, or any of the amazing goods that are available to us via small businesses. Then I thought about those small businesses and just how much paying for parking would deter locals from visiting downtown as frequently as we do.

I think about the people that work at the storefronts, likely not making a living wage as it is have to pay to park, or to opt to park in neighborhoods in the area instead. If you are a baker, that means walking to work very early in the morning while it's still dark to avoid paying for parking for an eight hour shift/ worry about making it to the meter in time, have to move your car mid shift, etc.

The longer I think about it, the more I think about just how the local small businesses will suffer. I think about just how flooded the neighborhood street parking (my street included) will be to avoid paying. I think about how my family and I will opt to be patrons of 1849 every Friday night instead of Thirsty Barrel. So therefore we won't be strolling downtown and grabbing an ice cream or Knick knack from a local shop. Our small businesses depend on locals. And locals choose to live here because we have the unique opportunity to cater to unique small businesses. It's what makes our downtown area so special.

#### I can go on...

Thanks for considering my opinion and I hope my anxiety around this situation is apparent as I have lived in downtown areas where paying to park (for basically no reason but greed typically) has driven out local business revenue entirely and created a ghost town of "for rent" spaces.
