Keep freeway access for South Auburn using existing city property

To all:

As I understand it, the ideal goals of altering "the triangle" intersection area are to reduce pollution while facilitating traffic flow in the most cost effective manner while minimizing impacts on local businesses and tax revenue.

In ideal conditions, a traffic circle is superior to a traditional 4-way intersection utilizing stop signs/traffic lights but the complicated nature

of the City's currently approved proposal raises significant concerns that this assumed truism holds, particularly as apparently no traffic flow studies have been done, nor comparisons with strengths/shortcomings of other complex traffic circles, nor full consideration of the impacts of the South Auburn "right turn only" design.

As the existing approved plan has significant costs now and in the future, requiring expensive alterations to be made to correct the "right turn only" deficiency, it is incumbent upon the City to use due diligence to evaluate all feasible alternatives.

A major shortcoming of the currently approved plan is the "right turn only" designation for southbound traffic on South Auburn Street. Critics have pointed out that freeway-bound travelers will likely use the Safeway parking lot as a work-around. There is also the unaddressed issue of Neal/Mill Street intersection impacts. Staff has suggested a future (and likely, very expensive) additional traffic circle and/or reengineering Bank Street to provide alternate access.

There is a third, unconsidered alternative: converting the City-owned parking lot just east of South Auburn (in the 150-block area) into a one-way street going from South Auburn east to Tinloy. This option would allow South Auburn southbound traffic to access the freeway. It would require a small land purchase or swap with the nearby hotel and a designated left turn lane on south bound South Auburn traffic (it would likely not allow traffic to travel east on Neal towards the freeway but this would still be possible by using Bank Street).

I have enclosed in the body of this letter a rough draft of a non-traffic circle option that illustrates this proposal (also attached), modifying my earlier design.

To reiterate advantages of minor and staged reengineering of existing streets using some variant of the enclosed proposal versus a complete large scale overhaul:

- reduces pollution
- maintains safety
- much lower costs
- minimizes impacts on traffic, businesses (and tax revenue) during and after construction
- would reduce number of traffic lights from 3 to 2 (or maybe one)

Under this alternate proposal, the two biggest expenses would be converting one block of the southerly portion of Hansen to a two way street and modifications to South Auburn and the City parking lot. Traffic studies would reveal whether a new traffic light would be required for the Hansen/Neal intersection versus keeping existing traffic control systems. For budget reasons, current under-freeway passage at South Auburn could be closed off with concrete barriers and developed later.

Respectfully, Terry Lamphier As a former building contractor, city planning department member and County Supervisor, I have a long history of creative problem solving. I always visited sites and met with affected parties and pertinent staff to learn first hand what opportunities and constraints existed, as I hope you have. If not, I'd be happy to meet you to walk the site. Thank you for your time.
