

**ADDENDUM TO THE
AGREEMENT BETWEEN THE CITY OF GRASS VALLEY AND THE GRASS
VALLEY SCHOOL DISTRICT FOR SCHOOL RESOURCE OFFICER SERVICES**

First Quarter SRO Absence – Fiscal Year 2026/2027

THIS ADDENDUM is entered into this 22nd day of June, 2026, by and between the CITY OF GRASS VALLEY, a municipal corporation (“CITY”), and the GRASS VALLEY SCHOOL DISTRICT (“GVSD”), collectively referred to as the “Parties.”

RECITALS

WHEREAS, the Parties entered into an Agreement for School Resource Officer Services with a term of July 1, 2026 through June 30, 2029 (the “Agreement”); and

WHEREAS, due to staffing constraints within the Grass Valley Police Department, CITY is anticipating being unable to provide a School Resource Officer to GVSD during the first quarter of Fiscal Year 2026/2027, specifically July 1, 2026 through September 30, 2026; and

WHEREAS, the Parties wish to address the temporary absence of SRO services and the corresponding adjustment to compensation for that period.

NOW, THEREFORE, for and in consideration of the mutual promises and covenants herein contained, the Parties agree as follows:

1. TEMPORARY SUSPENSION OF SRO SERVICES

Due to staffing constraints of the Grass Valley Police Department, SRO services as described in the Agreement and its Attachment A shall be suspended for the period of July 1, 2026 through September 30, 2026. CITY shall not be obligated to provide a School Resource Officer to GVSD during this period.

2. WAIVER OF FIRST QUARTER BILLING

Notwithstanding Section 3 of the Agreement, CITY shall not invoice GVSD for the first quarter of Fiscal Year 2026/2027 (July 1, 2026 through September 30, 2026), and GVSD shall have no obligation to make payment for that quarter. The quarterly billing and payment obligations set forth in the Agreement shall resume for the second quarter of Fiscal Year 2026/2027, beginning October 1, 2026.

3. AGREEMENT OTHERWISE UNCHANGED

Except as expressly modified by this Addendum, all terms and conditions of the Agreement shall remain in full force and effect. In the event of any conflict between this Addendum and the Agreement, this Addendum shall control.

4. **INTEGRATION**

This Addendum is incorporated into and made a part of the Agreement. All defined terms used herein shall have the same meaning as set forth in the Agreement unless otherwise specified.
