

meeting. The closed meeting, the agenda is a predetermined outcome, a

discussion in the open session will prejudice the position of the local agency in the litigation. I don't know who of you thinks you're suing who, but I mean, I'm objecting, so my opinion is not supposed to count because you could jeopardize, you could prejudice yourself in local agency litigation. The issue is this utility bill that I am not paying under protest because I have not received the services. I've got leaks in my street that I witnessed when they dug it up after they created a leak at my smart meter after they reset the meter. Then they reset it on a root that is growing along the leak that had existed in the street and told me that they would fix that, but they didn't. They filled it. Now I've got that tree growing right under my meter and nobody from the city willing to come out and actually take the root out like they said they would because I said leave it open so I could remove it. And they go, no, we're going to take it out and we'll fill it. but they didn't because now it's growing not only under my meter, but it is now determined that it's gonna come up between the sidewalk and the block wall, which is a disaster waiting to happen. I've tried to kill it several times, it's not working. It's too dead set on getting to the water leaks. We had, we on a shared sewer line, both of us paying the full cost of the sewer line, and we had, or he had, a backup, and he was blaming it on me. In the meantime, finally after three or four different people, the guy put a camera down and found a leak in the street of the sewer line, with roots and whatever is going on. I came in and I said to the city, look, it's on the city street. When you put in the smart meter, you came around and you told me that everything that you owned the shutoff valve at this point that you were going to charge to come on and off the property to turn off the water, that I had no choice in the matter. It was I could not use the valve. In the meantime, I had a leak at that point that was 13 years ago when they installed the smart meter. Every single one of all of you and every contractor and every homeowner seems to have some kind of mental block. I don't understand it. Impractical thinking. It's just impractical. You come and you say, well, if the water leak is on your side, it's your problem. If it's on our side of the meter, it's our problem. And then they come on and find a leak, and I said, don't be ridiculous. You installed the whole thing. If it leaks at all, then it's your installation, your problem. You can't foist that charge off on me. And then what? say, you must pay or we will turn off your water, and then notify me how illegal it is for me to live in a house that has no water, no hot and cold running water. You have breached every contract that there is, and when you have issues in the street concerning environmental waste leak in the city street, under the city street, and the city street is cracking and it's sinking in certain places around these cracks. And my house actually slipped and fell, slid, in keeping with the crack in the street. My insurance company tells me at that time that I have to pay to replace all the galvanized pipe. My house was supposed to be plumbed in copper. Meantime they dig up the city street, the city street is all galvanized. And then they send me a new

reinsurance bond. I pay \$5 a month and eventually they're going to replace my exterior lines for \$12,000. I am not giving you \$12,000 for you to determine that you're going to look into the fire risk. You shed off my water. I can't put out a fire, okay? You shut off my water, I lose my right to water, okay? And if you leave me on welfare, instead of actually forcing the insurance company to pay the claim that covered and breach every inch of the contract, it's the insurance manipulating your decisions. That's all it is. So I have plenty of comments on this, And I'm not allowing you to put this back to the treasurer, voice this charge for water usage that I don't owe you if you owe me repairs and an engineer's report to tell me why the city street is cracked in exactly the same places that my house cracked when I filed the homeowners insurance claim, and then you let the insurance company cancel my insurance policy as a known risk that I can't afford anyway if they go into court and get the judge to rule that they are entitled to discovery. They sanction me, sanction me, sanction me, sanction me for being unable to afford to provide discovery. Okay? When all they want to know is who I am, where I was born, when I was born, was I insured, was I injured, did I have a car accident, blah, blah, blah, blah, blah, blah, blah. It's pathetic. So I can't get an answer from you, and if you're going to be the one that is going to prejudiced in the open session, it's summary. If you're going to be prejudiced because I'm commenting and I've been telling you all, all this for 13 years and more, 26 years on the other hand, okay, then you need to stop and take notice. You can't put me with risk management and have them go into a closed session and say we're not going to deal with I guess they're going to sue somebody, maybe, or maybe it's just me that sued them. And then watch my house deteriorate and then say, but we've determined risk management doesn't want to negotiate. Please stop. OK.
