Certain roads in downtown, especially those North of Richardson Street need repair and haven't been fixed for over two decades. Numerous times we've called to find out when they'll be repaved properly and not just patched with asphalt. We're continuously told that "we're next on the list" but that's old news.

The parking on North Auburn Street has at times been choked when rentals are full. The police have been called when vehicles are left for over three days or even months. They call us back and tell us it's okay because the cars belong to neighbors. Yet, there is a law that prevents people from leaving a car on the street for over three days.

We've asked to have our curbs repainted with no reply making it necessary to do it ourselves. The runaround has lasted at least fifteen years. Our emails, letters, phone calls and online forms requesting help have all been ignored or passed on to somebody else until it comes back full-circle. The city has claimed that it cannot help with any of these issues. We pay our taxes and the extra Measure E sales tax that seems to be awarded to other areas.

1. We want to know when the streets will be repaired in our neighborhood and it should be in the near future. We've been waiting for too long.
2. We want the police to ticket those who abuse the no-parking areas or leave their vehicles in the street over three days.

3. We'd like the city staff to be considerate enough to return our calls and letters.
4. We want the city to form citizens committees for voicing our concerns about safety and traffic issues. We need to be heard and not ignored.
