RESOLUTION _____, 2019

A RESOLUTION APPOINTING RENEE WHEELER TO THE POSITION OF DIRECTOR OF FINANCE AND EX-OFFICIO CITY TREASURER.

WHEREAS, the Greeley Municipal Charter establishes the Department of Finance in Section 5-1; and

WHEREAS, Section 5-1 of the Charter further states that the head of the Department of Finance shall be the Director of Finance and Ex-officio City Treasurer; and

WHEREAS, Section 5-1 of the Charter further provides that the Director shall be appointed by the City Manager with the advice and consent of the City Council; and

WHEREAS, Victoria Runkle acted as the Director of Finance and the Ex-officio Treasurer until February 7, 2019; and

WHEREAS, Ms. Runkle was also an Assistant City Manager during her tenure with the City of Greeley;

WHEREAS, Renee Wheeler was employed as the Deputy Director of Finance during Ms. Runkle's tenure; and

WHEREAS, upon Ms. Runkle's resignation the City Manager immediately began recruitment for a suitable replacement candidate for the position of Assistant City Manager and determined that it was appropriate and necessary to appoint someone to act as the Interim Director of Finance and Interim Ex-officio City Treasurer while that search proceeded; and

WHEREAS, the City Manager appointed Ms. Wheeler as Interim Director of Finance and Interim Ex-officio City Treasurer beginning on February 8, 2019 and subsequently appointed Ms. Wheeler as the Director of Finance and Ex-officio City Treasurer on March 7, 2019 ; and

WHEREAS, pursuant to Section 5-1 of the Charter the City Council must consent to the appointment of the Director of Finance and Ex-officio Treasurer; and

WHEREAS, the City Council hereby finds that Ms. Wheeler has training and knowledge in municipal accounting, budgeting, taxation and financial control as required by Section 5-1 of the Charter; and

WHEREAS, the City Council finds that the City Manager's appointment of Ms. Wheeler to act as the Director of Finance and Ex-officio Treasurer is appropriate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREELEY, COLORADO:

1. The City Council consents to the appointment of Renee Wheeler as the Director of Finance and Ex-officio Treasurer.
2. The Director of Finance and Ex-officio Treasurer shall have the authority to exercise all duties, responsibilities and appointments as may be assigned to her by the Greeley Municipal Charter, the Greeley Municipal Code and the City Manager and Assistant City Manager.
3. This appointment shall continue until such time as a new Resolution is passed, as required by Section 5-1 of the Greeley Municipal Charter.
3. This Resolution shall be effective *nunc pro tunc* to February 8, 2019.
