### STREET CRIMES UNIT


- The District 16 Street Crimes Unit responded to a disturbance where contact was made with a suspect in a vehicle. Probable cause to search the vehicle was established. Cocaine, fentanyl, and drug equipment was found inside the suspects' vehicle and purse. The suspect was charged accordingly.
- The District 16 Street Crimes Unit conducted a traffic stop where probable cause to search the vehicle was established and upon searching the passenger fled on foot. The passenger was arrested, found in possession of a concealed firearm and charged accordingly.
- The District 16 Street Crimes Unit conducted a traffic stop on a vehicle. After the vehicle stopped the driver fled on foot to their residence. Prior to entering the residence, the suspect was apprehended, found to be in possession of cocaine and charged accordingly.


#### PROPERTY DETECTIVES


- On 01/03/24 a suspect entered a liquor store and stole three bottles of liquor. The suspect then fled on foot and deputies searched the area but were unable to locate the suspect. On 01/07/24 the same suspect shoplifted from this same location again, twice that day. Detectives were able to positively identify the suspect who was located and apprehended at which time the suspect confessed, post Miranda. These cases were cleared by arrest.
- On 12/23/24 a vehicle burglary occurred in the same parking lot where a stolen vehicle was recovered. A suspect was identified in several vehicle burglaries in the area. The suspect confessed to their involvement in the stolen vehicle and their involvement in the vehicle burglary. This case was cleared by arrest.
- A shoplifting incident occurred for a nearly \$4000 loss at a city business. It was determined several of the cases from this business are related. Three out of the four suspects in this case have already been identified and apprehended. An employee working at this business was developed as a suspect, where probable cause was established and the suspect was arrested with incident.

# DATA ANALYSIS

The data included in this report is charted and graphed to illustrate and compare changes over a specific time period. These charts and graphs are utilized to assist in determining crime trends and to measure enforcement efforts. This data is utilized in conjunction with other analysis to develop directed patrol and various enforcement activities.
