

RESOLUTION NO. 2022-01

A RESOLUTION ADOPTED BY THE CITY COUNCIL OF THE CITY OF GREENACRES, FLORIDA, AUTHORIZING THE AGREEMENT BETWEEN THE CITY OF GREENACRES AND THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR DISTRICT IV MAINTENANCE MEMORANDUM OF AGREEMENT, ALONG WITH EXHIBITS "A", "B" AND "C" OF THE AGREEMENT; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Transportation has jurisdiction over State Road 882 (Forest Hill Boulevard) as part of the State Highway System as described in Exhibit "A"; and

WHEREAS, the City of Greenacres seeks to install or have installed by permit and maintain certain landscape improvements within the right of way of State Road 882 (Forest Hill Boulevard) as described within Exhibit "B"; and

WHEREAS, the City of Greenacres is agreeable to maintaining those landscape improvements (as described within "Exhibit "C") within City limits including plant material, irrigation systems and/or hardscape which contain specialty surfacing and agree such improvements shall be maintained by periodic mowing, fertilizing, weeding, litter pick-up, pruning, necessary re-planting, irrigation repair and/or repair of the median concrete replacement associated with the specialty surfacing as needed; and

WHEREAS, the City of Greenacres and the Florida Department of Transportation recognize the need to enter into an Agreement designating and setting forth the responsibilities of each party regarding this project; and

WHEREAS, it in consideration of the terms and conditions of the Agreement, it has been determined to be in the best interest of the City of Greenacres and the Florida

Department of Transportation to enter into the District Four Maintenance Memorandum of Agreement as outlined in Florida Department of Transportation Permit No. 2021-L-496-0003.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENACRES, FLORIDA, THAT:

Section 1. The City Council grants authorization to enter into the State of Florida Department of Transportation District Four Landscape Maintenance Memorandum of Agreement.

Section 2. The City Council hereby directs the City Clerk to transmit two (2) certified copies of his resolution to the State of Florida Department of Transportation for its authorization and execution of this Agreement.

Section 3. This resolution shall be effective upon its adoption.
