ORDER OF VIOLATION - IMPOSING FINE

The Special Magistrate of the City of Green Cove Springs, Florida, states as findings of fact and conclusions of law in the present case, the following:

- (1)HARRISON ALTHEA T HEIRS ET AL the owner of the property in Green Cove Springs, Florida with the parcel no.38-06-26-017710-000-00, also known as 719 N Pine Ave, Green Cove Springs, FL 32043-2430, (the "Property");
- (2) That the property owner was properly notified of said violations and given a reasonable time to bring the Property into compliance;
- (3) That the property owner was properly notified regarding the hearing held on 06/19/19 regarding said violations;
- (4) That at the 06/19/19, hearing, the evidence presented demonstrated that the Property was in violation of the Green Cove Springs City Codes;
- (5) That an Administrative fine of One Hundred Dollars (\$100.00) is assessed. Whive fee
- (6) That a daily fine of twenty five (\$25) dollars per day will be assessed for each day the property remains out of compliance after 07/05/19. $\supset \cup_{i \in S} \cup_{i \in$

ACCORDINGLY, it is hereby ORDERED AND ADJUDGED that

- (A)HARRISON ALTHEA T HEIRS ET AL is in violation of the Green Cove Springs City Codes, and is hereby fined an administrative fine of One Hundred Dollars (\$100.00).
- (B)HARRISON ALTHEA T HEIRS ET AL is in violation of the Green Cove Springs City Codes, and a daily fine of twenty five (\$25)dollars per day will be assessed for each day the property remains out of compliance after 07/05/19.

(C)It shall be the responsibility of HARRISON ALTHEA T HEIRS ET AL to immediately contact the City code Enforcement Officer at (904) 297-7500 ext 3302 to confirm its compliance.
