City Attorney Arnold reads Ordinance No. O-17-2024 by title.

Development Services Director Michael Daniels presents the ordinance.

Mayor Kelley opens the public hearing.

Ellen Avery-Smith with Rogers Tower speaks and advises Mr. Daniel did a great job on the presentation and she is available for any questions.

Felecia Hampshire 508 Franklin St. GCS questions the costs of the homes and advises she supports affordable housing.

Ms. Smith speaks on affordable housing and advises this project is a marker rate project not based on income.

Mayor Kelley speaks about affordability and believe coming up with a product that is the right size people are looking for. He believes adding duplexes is a creative way to help with the cost. Joe Sobotta 212 North St. GCS speaks about the cost of everything going up and it has nothing to do with poverty.

Following no further public comments, Mayor Kelley closes the public hearing.

Council discussion following concerning the numbers of units, parking, and the cost of the housing.

Ms. Smith advises there is product mix in the community and the area this is what the market is asking for.

5. First Reading of Ordinance O-16-2024 - Request for rezoning of 24.22 acres of property located in the 4000 block of South US 17:

From: MUH, Mixed Use Highway To: C-2, General Commercial *Michael Daniels*

City Attorney Arnold reads Ordinance No. O-16-2024 by title.

Development Services Director Michael Daniels presents the ordinance.

Mayor Kelley opens the public hearing.

Ellen Avery-Smith with Rogers Towers advises this property is owned by DR Horton and the request is to rezone it to commercial for use as a grocery-anchored shopping center and other kinds of retail spaces that would be complementary to the rookery development.

Van Royal 3688 La Costa Ct. GCS speaks in favor for this and asks the Council once they see the site plan to make sure wide sidewalks are planned.

Felecia Hampshire 508 Franklin St. GCS asks if a site plan will be available because she would like to see what is going into the shopping area.

Ms. Smith advises this is just a rezoning but a site plan will have to come before Council and it will likely be a grocery/shopping center.

Following no further public comments, Mayor Kelley closes the public hearing.

Council discussion concerning traffic and sidewalks.

Motion to approve on first reading of Ordinance O-16-2024 for form and legality, to amend the Zoning of Parcel ID 016579-000-00 from MUH, Mixed Use Highway to C-2, General Commercial.

6. First Reading of Ordinance O-19-2024, requesting for closure of transportation connection between Grove Street and St Johns Avenue *Michael Daniels*

City Attorney Arnold reads Ordinance No. O-19-2024 by title.

Development Services Director Michael Daniels presents the ordinance.

Mayor Kelley opens the public hearing.

Joe Sobotta 212 North St. GCS speaks about the parking situation and who is concerned

Mr. Daniels advises there have been a significant number of complaints back and forth about all of the requirements that were set forth in the 2016 special exception. Mr. Daniela also advises this has been an ongoing issue between the property owners and the neighbors.

James Whitehouse on behalf of Springs Chapel advises when the special exception was approved in 2016, the residents did not want them using Grove Street to access the church and school because their fears were that people would use Grove and then go down St. John's. Mr.

Whitehouse advises this caused a Code Enforcement issue, so a special exception was approved.

Van Royal 3688 La Costa Ct. GCS asks is St. Vincent's has been reached out to. They have an approved site plan to access the emergency room on Grove Street.

Mr. Daniels advises it would be on their property along Grove St.

Mr. Sobotta questions why people can't come off St. John's onto the property.

Mr. Whitehouse speaks concerning the property and the decision of the Planning & Zoning Board.

Following no further public comments, Mayor Kelley closes the public hearing.

Council discussion followed concerning the traffic, parking and residents thoughts on closing the street.

Mayor Kelley reopens the public hearing

Mr. Royal speaks about the wall and making it a dead end.

Following no further public comments, Mayor Kelley closes the public hearing.

Council discussion followed concerning the closing of the street and making it a dead end and make it safe for the student drop off and pickup.

Motion to pass Ordinance No. O-19-2024, determining closure of transportation connection between Grove Street and St. Johns Avenue with the additional condition of asking the zoning director to come up with language that specifies explicitly that the city will grant a specific advance notice before changing the condition of the closure of Grove Street.

Assistant Water Utilities Director Scott Schultz advises the lift stations are located in Magnolia Point and they have had little improvements made over the last 4 years but these two need rehabilitation in order to move further along.
