Council Member Gaw advises he would like to discuss the Police Department concerning the gap between retirement and Medicare and there being a plan in place for officers when they retire but have not met the state retirement age.

Officer Newton with the Green Cove Springs Police Department speaks about the effort that is starting to take place concerning medical benefits after retirement. The gap falls when someone reaches 25 years and can retire but they do not meet the age requirement for the state of Florida to receive retirement benefits. He advises, he along with other officers are looking at a funding option for this gap.

Human Resources Director Dee Jones advises she has helped with this benefit in the past. There are a lot of moving parts, and it will take some time, but it is doable to create a program to help fund medical benefits when there is a gap between retirement years and age. The program she helped start, started with public safety then branched out to every employee at the municipality.
