

**STATE REVOLVING FUND
AMENDMENT 2 TO LOAN AGREEMENT DW100440
CITY OF GREEN COVE SPRINGS**

This amendment is executed by the STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (Department) and the CITY OF GREEN COVE SPRINGS, FLORIDA, (Project Sponsor) existing as a local governmental entity under the laws of the State of Florida. Collectively, the Department and the Project Sponsor shall be referred to as “Parties” or individually as “Party”.

The Department and the Project Sponsor entered into a State Revolving Fund Loan Agreement, Number DW100440, as amended, authorizing a Loan amount of \$2,171,400, excluding Capitalized Interest; and

The Loan Amount, Semiannual Loan Payment amount, and Project costs need adjustment to reflect actual costs; and

Certain provisions of the Agreement need to be revised.

The Parties hereto agree as follows:

1. The total amount awarded is \$2,171,400.
2. The Loan Service Fee is \$43,428. The fee represents two percent of the Loan amount excluding Capitalized Interest; that is, two percent of \$2,171,400.
3. The total amount of the Loan is \$2,220,131.03. This consists of \$2,171,400.00 disbursed to the Project Sponsor, plus accrued Capitalized Interest of \$5,303.03 and service fee charges of \$43,428.00.
4. The Semiannual Loan Payment amount is hereby revised and shall be in the amount of \$123,029.26. Such payments shall be received by the Department on April 15, 2026, and semiannually thereafter on October 15 and April 15 of each year until all amounts due hereunder have been fully paid.
5. Project Costs are revised as follows:

The Project Sponsor and the Department acknowledge that changes in Project costs may occur as a result of an audit. Unless this Agreement is amended subsequent to an audit, the following Project disbursements shall be final.

6. All other terms and provisions of the Loan Agreement shall remain in effect.
