City of Green Cove Springs 2nd Public Hearing Community Development Block Grant Application for FY 2023-2024

The City of Green Cove Springs plans to apply to Florida Commerce for a FFY 2023-2024 Small Cities Community Development Block Grant (CDBG) in the amount of \$1,275,000.00 in the Neighborhood Revitalization category. For each activity that is proposed, at least 70% of the funds must benefit low- and moderate-income persons. The activities, dollar amounts and estimated percentage benefit to low-and-moderate-income persons for which the City of Green Cove Springs is applying are:

Service Area #1 Flood and Drainage Improvements Service Area:

Service Area #1 includes all the occupied residential properties who benefit from the City's Oakridge Basin Stormwater Collection system.

03I Flood and Drainage Activity - The City of City of Green Cove Springs' Oakridge Basin Storm Water Collection System does not adequately provide storm water drainage during significant rain events. During significant rain events, the Oakridge Stormwater Basin floods. The activity in Service Area #1 proposes to install approximately 5,800 LF of storm water piping, swales and inlets along with improvements to the stormwater retention pond located at the corner of MLK Boulevard and Oakridge Avenue and all required restoration to all disturbed areas. The proposed storm water piping will include swales and inlets. Installation will be along the following streets:

- Martin Luther King, Jr. Boulevard between Oakridge Avenue on the west and Highland Avenue on the east
- North Street between Oakridge Avenue on the west and Highland Avenue on the east
- Center Street between Oakridge Avenue on the west and Highland Avenue on the east
- Palmer Street between Oakridge Avenue on the west and Highland Avenue on the east
- Spruce Street between Oakridge Avenue on the west and Highland Avenue on the east
- Forbes Street between Oakridge Avenue on the west and Highland Avenue on the east
- Walnut Street between Oakridge Avenue on the west and Highland Avenue on the east
- Highland Avenue between Martin Luther King, Jr. Boulevard on the north and Walnut Street on the south
- Oakland Avenue between Martin Luther King, Jr. Boulevard on the north and Walnut Street on the south

These stormwater drainage system improvements will allow the Oakridge Service Area to drain properly during significant storm events
