MINUTES

Call to Order

Chairwoman Boucher called the meeting to order at 10:01am.

ACTION ITEMS

1. Approval of Minutes of the July 17, 2025 Meeting

Motion was made to approve the minutes of the September 18, 2025 meeting.

Motion made by Commissioner Royal, Seconded by Commissioner Timberlake.

2. Review of CRA Improvement Assistance Grant Applications

Lyndie Knowles, CRA Secretary, presented the 3 applications for the CRA Facade Improvement Assistant Grants. The intent was to present the projects and then have the board forward their score sheets for each project to staff. Commissioner Timberlake asked if the decision on award could be made at the meeting instead of waiting to score. It was decided that the recommendation of approval would be made at this meeting and not at a later date.

1. Applicant James H. Davie II of 733 N Palmetto Avenue proposed improvements totaling \$12,116.91 and was requesting grant amount of \$8,481.84. Attorney Jessica Skapetis was present on behalf of the applicant.

Board discussion followed.

The board approved all items except the rear windows and asked a condition of the replacement of the no parking signage and a refresh of the monument signage. The revised grant total awarded was \$6,066.56.

2. Applicant Jacqueline Tomlin of 520 N Orange Avenue proposed improvements totaling \$18,134.74 and was requesting grant amount of \$10,000. The applicant was present and gave her thoughts and requested input from the board.

Board discussion followed.

The board approved all items on the conditions that the boat would be removed, the fence would be removed (pending ownership confirmation), installation of window treatments on southside windows and that all signage meet the City's sign ordinance. The grant total awarded was \$10,000.

3. Applicant William Welsh of 800 N Orange Avenue proposed improvements totaling \$15,425.23 and was requesting grant amount of \$10,000. The applicant was not present.

Board discussion followed.

The board approved the grant with the condition that the pressure washing must include the building along with the retaining wall and the trimming of all trees on the property. The grant total awarded was \$10,000.

Commissioner Burke left the meeting at 10:45am

A motion was made to approve the grants as presented.
