- 3. Visit/Explore Green Cove Springs Initiative Tiffanie Kelley: Discussion the Visit/Explore Green Cove Springs initiative. CAC was informed the city will have kiosks with sizzle reels in city hall. The committee will continue to discuss ideas, potentially a tourism map, to contribute to the initiative.
- 4. Officers for CAC: Chairman Thomas Smith resigned from the committee to pursue city council aspirations and was no longer able to hold a position on the committee as a candidate.
