ORDER OF VIOLATION - IMPOSITION OF LIEN AND CONTINUATION OF FINES

(A)MALDONADO RAUL & MARISELA is assessed \$7,200.00 on the current daily and administrative fines. A lien shall be placed on the property in this amount.

(B)A certified copy of this Order Imposing Fine and Lien shall be recorded in the public records of Clay County, Florida and shall continue as a lien against the Property upon which the violation exists and upon any other real or personal property owned by MALDONADO RAUL & MARISELA, pursuant to Section 162.09, F.S. (C) The Daily fine of \$25 will continue to accrue until the property is brought into compliance.
