## Minutes of the Green Cove Springs Citizens Advisory Committee Meeting Dec 9, 2021

- 1. Call to Order: Chairman Thomas Smith called the meeting to order at 6:30 PM in the City Council Chambers.

- **2. Public/Audience Comments:** In a private citizen capacity William Meeks spoke about his Non-profit organization and the current project for the holiday season. All Creations Intertribal is hosting a charity give-a-way for children in need. 128 children are registered to be recipients.
- **3. Approval of previous minutes:** A motion was made by Cindy Ross to approve the minutes, Seconded by Henrietta Francis. Motion Approved.
