12-7-4(d)Roofs.1.Use of "false fronts" / parapets on commercial buildings in the central business district is encouraged to screen flat roofs.2.False fronts should be designed to screen mechanical and HVAC equipment from the street level.3.Flat roofs shall be designed to accommodate maximum snow loading conditions.
