RESOLUTION NO. 49– 2024**

**A RESOLUTION OF THE TOWN OF GRAND LAKE, COLORADO TO PURCHASE A
TRAILER FROM THE GRAND LAKE CHAMBER OF COMMERCE**

WHEREAS, the Board of Trustees of the Town of Grand Lake, Colorado (the “Board”) pursuant to Colorado Statute is vested with the authority of administering the affairs of the Town of Grand Lake, Colorado (the “Town”); and

WHEREAS, Grand Lake Chamber of Commerce (the “Chamber”) is the owner of a trailer that functions as a mobile stage for Town and Chamber events VIN number IDTL051993AA (hereinafter the “Trailer”); and

WHEREAS, the Town and Chamber have cooperated to utilize and allow various other performers to make use of the Trailer, however, doing so requires an additional step of the Town securing permission for use of the Trailer prior to each performance; and

WHEREAS, the Town and the Chamber believe it to be in the best interest of the Town and the Chamber as well as potential performers on the Trailer for the Town to take ownership of the Trailer and streamline the application process for use of the Trailer; and

WHEREAS, the Chamber is graciously willing to transfer the Trailer to the Town and the Town desires to accept ownership of the Trailer.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE
TOWN OF GRAND LAKE AS FOLLOWS:**

1. The Town hereby agrees to purchase the Trailer, VIN number 1DTL051993AA, from the Chamber for one (\$1.00) dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged.
2. The Mayor or his designee is hereby authorized to accept ownership of the Trailer and take any and all steps necessary to complete the transfer of the Trailer and register the same.
3. Severability: If any section, paragraph, sentence, clause, or phrase of this Resolution is held to be unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining portions of this Resolution. The Board of Trustees declares that it would have passed this Resolution and each part or parts thereof irrespective of the fact that any one part or parts be declared unconstitutional or invalid.
4. Repeal: Existing resolutions or parts of resolutions covering the same matters as embraced in this Resolution are hereby repealed and all resolutions or parts of resolutions inconsistent with the provisions of this Resolution are hereby repealed.
