<u>Introduction:</u> An application for a Special Event Liquor Permit was received from the Grand Arts Council with the supporting documentation, and appropriate fees.

The request is to sell malt, vinous and spirituous liquor by the drink for consumption on the premises only for their "Opera Night" to be held Saturday, February 11, 2023, from 6:00 p.m. to 9:00 p.m. at 1025 Grand Avenue. The Grand Arts Council qualifies for a Special Events Liquor Permit in that it is incorporated with the State of Colorado as a non-profit and has not received more than 15 Special Events Liquor License Permits for 2023, this is their first request.

The Board must investigate the application and could deny the permit if its issuance would injure the public welfare by reason of the nature or location of the special event, or failure of the applicant to conduct past special events in compliance with applicable laws and regulations.

<u>Neighborhood Boundaries:</u> The town limits of Grand Lake are the neighborhood boundaries. The proposed location is at the Community House, 1025 Grand Avenue which is more than 500 feet from any educational institution; therefore, State Statute does not prohibit liquor from being sold from this location.

Financial Details: The respective license fees have been paid.

<u>Background Check:</u> The application was turned over to the Grand County Sheriff's Office, they found no adverse information that would affect the issuance of the license.
