


AN ORDINANCE TO AMEND THE CODE OF ORDINANCES FOR THE CITY OF GROSSE POINTE WOODS, CHAPTER 2 - ADMINISTRATION, ARTICLE III - DEPARTMENTS, DIVISION 2 - DEPARTMENT OF PUBLIC SERVICES; SECTION 2-129, AND DIVISION 3 - PARKS AND RECREATION DIVISION; SECTIONS 2-159, 2-160, 2-161 (a - g), AND 2-162, AND DIVISION 5 - COMMUNITY CENTER DIVISION; SECTIONS 2-193, 2-194, 2-195 (a - f), AND 2-196, TO CHANGE THE JURISDICTION AND RESPONSIBILITIES FOR PARKS AND RECREATION AND FOR THE COMMUNITY CENTER FROM THE PUBLIC SERVICES DEPARTMENT TO THE DEPARTMENT OF PARKS AND RECREATION.
