Subject: Licensé Plate Reader Project

Several years ago, the Grosse Pointe Public Safety Foundation, was formed to assist the Grosse Pointe/Harper Woods Public Safety Departments with projects. The Foundation has already funded a radio repeater for Grosse Pointe South High School and soon will be installing a repeater in Grosse Pointe North High School.

The next project is for License Plate Readers (LPR) to be installed throughout the Grosse Pointes and Harper Woods. License Plate Readers capture license plates when a vehicle passes by the reader. The license plate information is used for investigative purposes to locate criminals and diffuse crime trends.

The Grosse Pointe and Harper Woods Directors have worked with the Foundation and Motorola on this project. The Grosse Pointe Public Safety Foundation is paying for the initial cost (\$45,845.00) except for the monthly data plan for the reader's sim card. Estimated yearly total cost would be \$2,700.00 for all 5 LPR's.

After the first year we will be responsible for the following: Licensing Agreement of \$2,750.00, Data Sim Card plan \$2,700.00, and the Investigative Data Platform \$4,250.00, for a total of \$9,700.00. This will be an annual budgeted item for Public Safety.

The LPR's will be at the following locations:

- Allard East of Harper
- N/B Mack at Blossom Lane
- E/B Vernier near West city limits
- S/B Mack at Brys
- S/B Marter at Parkway

We are trying to cover the main entrances into the city. Ascension St. John recently installed more cameras on their complex including a camera at the entrance. I am working with the hospital to see if they would fund an LPR. If the Foundation receives more donations, we could be adding more LPR's in the future I don't have any hesitation or concerns with this project. The department will have a policy in place when we go live with the readers. A lot of surrounding communities already use LPR's and found it to be great tool in the fight against crime. We strive to make the Grosse Pointe's as safe as it can be to live, work and visit. Let me know if you have any questions or would like to discuss more in detail.

This agreement has been reviewed and approved by City Attorney Matthew Zalewski. I am requesting that City Administration will sign the agreement.

#### Re. Restricted Gift of the Grosse Pointe Public Safety Foundation ("GPPSF")

Dear Mr. Schulte:

GPPSF is a 501(c)(3) public charity committed to providing the law enforcement agencies of the five Grosse Pointes and Harper Woods with cutting edge tools and technologies to maximize the security and safety of our community.

On November 14, 2024, the Board of Directors of the GPPSF unanimously approved a gift to the City of Grosse Pointe Woods ("GPW") of five (5) Motorola Solutions ("Motorola") License Plate Readers ("LPRs"), related equipment, certain installation and configuration costs, and all related license fees for the first year of implementation (collectively, the "LPR System"). The cost of the LPR System will be fully funded by GPPSF, but the LPR System, including the location and placement of each LPR, has been selected by GPW. The attached proposal from Actron Integrated Security Systems, an approved Motorola contractor ("Actron") which has been approved by GPW, outlines the LPR packages selected by GPW municipal officials, including law enforcement, in conjunction with Actron and Motorola.

Title to the LPRs, related equipment, licenses, and warranties outlined in the proposal will be in GPW's name. All annual license costs outlined in the proposal beyond the first year of implementation are the responsibility of GPW. All maintenance, hard wiring and related work and material (e.g. trenching, electrical), increase in municipal cellular data plan costs, and other operational costs to keep the LPR System in good working order shall be the responsibility of GPW.

GPW shall endeavor to budget and expend sufficient funds to maintain the LPR System in good operating condition throughout the useful life of the LPR System.

These terms shall apply to additional gifts by GPPSF to GPW relating to the LPR System (i.e. additional LPRs, equipment, materials, and installation) except that GPW shall be responsible for all license fees upon deployment of additional LPRs to the LPR System). However, GPPSF has not committed any additional gifts, and GPW should not expect or rely on any funding from GPPSF relating to the LPR System, including maintenance and operational costs, beyond this initial gift.

GPW agrees to hold harmless GPPSF, its agents, servants, employees, officers and directors from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees, which may be sustained or claimed to be sustained by any person, and all damages to property, caused by or in connection with GPW's use, possession, ownership, sale or disposal of the LPR System.

GPW agrees to release, waive, discharge and covenant not to sue GPPSF and its agents, servants, employees, officers and directors for any and all claims, including but not limited to the negligence of GPPSF, its agents, servants, employees, officers and directors resulting in personal injury, accidents or illnesses (including death, or property loss), related in any way to the gift or the LPR System.

GPPSF is excited to be able to help provide this needed law enforcement tool to GPW and ready to accept the proposal and place the order with Actron following receipt of this signed letter.
