SUBJECT: Purchase – ½ Ton Pickup Truck for GIS Technician

In the 2022/23 fiscal year, the Department of Public Works needs to purchase a lightweight vehicle to be utilized by the city's GIS Technician. The GIS Technician inputs water service lines now required by the Michigan Department of Environment, Great Lakes, and Energy (EGLE) and trees, fire hydrants, stop boxes, gate valves, etc. for permanent city records. With the purchase of this vehicle, use of the city's heavy or mid-weight trucks will not be needed and make them available for a crew chief or operator to use.

The department recommends to purchase one 2023 Ford F-150 XL regular cab pickup truck to be utilized by the city's GIS Technician.

Gorno Ford has provided a quote to purchase one 2023 Ford F-150 XL regular cab pickup truck through the MiDeal Program for \$40,204.00. The MiDeal Program is a cooperative purchasing program for state and government agencies and the city can take advantage of the government pricing offered.

Therefore, I recommend the purchase of one 2023 Ford F-150 XL regular cab pickup truck from Gorno Ford, 22025 Allen Road, Woodhaven, MI 48183 in the amount of \$40,204.00. Funds are available for this purchase in the Fiscal Year 2022/2023 Budget in the Motor Vehicles Capital Equipment – Public Works account No. 640-852-977.599.
