Requested Action

• Motion to set the Hamburg Township sewer rate at \$167.00 per quarter per REU effective July 1, 2024, with an allocation of \$124.78 towards operation and maintenance, and \$42.22 towards debt service and to set the late penalty at \$5.00 per quarter.

Background

Part of the annual budget approval process requires the annual establishment of sewer utility operations & maintenance and debt service fees. For the FY 24/25 budget, we have determined that the sewer rate needs to be increased. The quarterly charge will increase 2.3% to \$167.00 for FY 24/25. The allocation between operations & maintenance and debt needs to be changed as shown in the table below.

Re: Sewer Rate - 24-25 Fiscal Year

At a meeting with the Supervisor and the Director of Accounting yesterday, we decided that it would be prudent to implement a small sewer rate increase of 2.5% for the upcoming fiscal year primarily due to PFAS concerns. This will raise the rate from \$163.30 to \$167.00 per quarter when rounded down. We've found that round numbers cause less confusion for our customers and make it easier for those at the Township who are taking in payments.
