We the undersigned, as the record owners of land constituting more than 50% of the total linear road frontage in a proposed special assessment district described in the attached Appendix A, hereby respectfully **PETITION THE HAMBURG TOWNSHIP BOARD** for road maintenance as described below (the "Project") under authority of the Township Public Improvements Act (Act No. 188, Public Acts of Michigan, 1954, as amended) for the gravel portion of Kingston Drive, Kingston Place, Kingston Court, Santiago Court, St. James Court and Compton Court, all being private roads located in Hamburg Township. The project shall be paid for through special assessments levied on those properties located within the district for a period of ten (10) years. Property owners are requesting that the method of assessment for road maintenance be levied on a per parcel basis.

**Project Description:** The project consists of establishing a road maintenance special assessment district to benefit those properties having ingress and egress along the gravel portion of Kingston Drive, Kingston Place, Kingston Court, Santiago Court, St. James Court and Compton Court.

Road maintenance shall consist of the following services:

- 1. Road Grading to be done up to five (5) times per year as necessary; and
- 2. Up to 300 cubic yards of road quality (21AA) gravel to be installed on an annual basis as necessary, and
- 3. Application of Brine for the purpose of dust control at the following schedule One week prior to or after the Memorial Day holiday, one week prior to or after the 4<sup>th</sup> of July holiday, and one week prior to or after the Labor Day holiday, not to exceed three (3) times per year.

We, the petitioners, further understand that the costs of the Project (including any related engineering and/or legal costs) will be assessed against our land and the other lands in the proposed district, whether or not the Project is completed. In the event that the Special Assessment district is not created, the undersigned agree to reimburse the Township for all such costs that the Township may assess against our property.

Enclosed is a copy of the official Notice of Improvement Hearing to re-establish the Kingston Drive Area road maintenance special assessment district (S.A.D.). The district shall serve the properties located on the gravel portion of Kingston Drive, Kingston Place, Kingston Court, Santiago Court, St. James Court and Compton Court. Road maintenance services will consist of road grading up to five (5) times per year, the annual installation of up to three hundred (300) cubic yards of 21AA road quality gravel, and dust control applications up to three (3) times per year.

The Township Board has scheduled the first public hearing for Tuesday, July 19<sup>th</sup>, 2022 to begin at **5:30 p.m**. at the Township Offices located at 10405 Merrill Road. The purpose of the meeting is to discuss the desire to re-establish the district, the district boundaries and the estimated cost of the project. The estimated road maintenance costs for the first year of the district is \$15,887.31 which will be split equally among the 29 parcels in an assessment of approximately \$547.84 each.

If after the first public hearing there is still enough support to move forward with reestablishing the special assessment district the Board will pass a resolution to schedule the  $2^{nd}$  public hearing, tentatively planned for August 16, 2022, which will provide the actual amount of your assessment that will appear on the December 1, 2022 tax bill.

- (3) The Township plans on imposing special assessments on the properties located in the Special Assessment District to pay for the costs of the road maintenance.



## RESOLUTION TO RE-ESTABLISH THE KINGSTON DRIVE AREA SPECIAL ASSESSMENT DISTRICT DIRECT PREPARATION OF ASSESSMENT ROLL AND SET DATE OF SECOND PUBLIC HEARING

WHEREAS, the Township Board ("the Board") of the Township of Hamburg, Livingston County, Michigan ("the Township") received Petitions signed by more than 50% of the total (approx. 9,711 linear feet) of the proposed Special Assessment District described hereinafter, and accordingly, determined to proceed under the provisions of Public Act 188 of 1954, as amended, to secure plans and estimates of cost together with a proposed Special Assessment District for assessing the costs of the proposed road maintenance to schedule a public hearing upon the same for this date, and

WHEREAS, the plans, estimates of cost and proposed Special Assessment District were filed with the Township Clerk for public examination and Notice of the within hearing upon the same was published and mailed in accordance with law and statute provided as shown by the Affidavit pertaining thereto on file with the Township Clerk, and

**WHEREAS,** in accordance with the aforesaid Notices, a hearing was scheduled on this 19<sup>th</sup> day of July, 2022, commencing at 5:30 o'clock p.m. and all persons given the opportunity to be heard in the matter, and

WHEREAS, as a result of the foregoing, the Township Board believes the project to be in the best interests of the township and of the district to be re-established therefore;

#### NOW, THEREFORE, BE IT HEREBY RESOLVED as follows:

1. That this Township Board does hereby determine that the Petitions for the <u>Kingston Drive Area - Road Maintenance Special Assessment District</u> were properly signed by the record owners of land whose frontage constitutes more than 50% of the total (9,711 linear feet) upon the proposed improvement.

- 2. That this Township Board does hereby approve the plans for the road maintenance as requested by the Petitions and the preliminary estimate of costs for the first year to establish the district in the amount \$15,887.31, which was bid out for the final determination of costs.
- 3. That this Township Board does hereby re-establish, determine and define as a Special Assessment District to be known as the Kingston Drive Area Special Assessment District within which the costs of such improvements shall be assessed according to benefit and which consists of the lands identified more specifically identified by the following permanent parcel numbers:
